

## **CONSTRUCTION CHANGE ORDER NO. 1**

## **REASON FOR CHANGE:**

This change order is required to address several conditions that contributed to unexpected costs during construction.

- There were several discrepancies between the plan quantities and the actual quantities installed in the field. Examples include Concrete Class IV, Culverts; Reinforcing Steel, Misc.; Sodding, Bahia; Sodding, St. Augustine for a total of \$181,424.07, or approximately 73% of the change order amount.
- Unforeseen utilities not shown on the plans were encountered in the field requiring field modifications to new structures and adjustments of quantities. An example includes adding a large conflict structure to the box culvert storm sewer for a gravity sewer line.
- Modifications to a storm sewer structure were required to accommodate a future storm sewer connection from the north that was not addressed in the plans.
- There were significant additional costs associated with the restoration of an easement at 5399 97th Way North.

The remaining items address additional costs for work changes to County Utilities. The consultant will not be responsible to pay for these overages, as they are additional items that should have been advertised in the original bid submittal sheets and included in the contractor bid submittal.

The contractor agrees to conform to all existing contract specifications as well as those specific to this work.

There is no time extension associated with this change order.
