## LOCAL STATE OF EMERGENCY

11. Local State of Emergency.

Commissioner Eggers discussed the past year related to COVID-19, reflecting on the Stay at Home order in the spring of 2020, various trends in positivity rates over the course of the year, and the increased activities in the community as a result of the introduction of the vaccine; whereupon, he stated that although the Commission will not be voting on modifications to the mask ordinance today, there will be a discussion regarding the ordinance. He asked that citizens and Commission members be respectful in their comments.

Mr. Burton indicated that the action being requested is to extend the Local State of Emergency until April 23; whereupon, Florida Department of Health in Pinellas County Director Dr. Ulyee Choe related that COVID-19 case counts and percent positivity rates are increasing; that, according to the Centers for Disease Control and Prevention (CDC), COVID-19 was the third most common cause of death in the United States in 2020; and that there has been an increase in hospitalizations over the last month.

Dr. Choe discussed COVID-19 variants that are present in the United States, the number of vaccinations administered within Pinellas County, and the progress towards herd immunity; whereupon, Mr. Burton provided information regarding vaccination efforts in the county.

In response to a query by Commissioner Peters, Dr. Choe related that individuals infected with COVID-19 may have less antibodies than what they would receive through the vaccine;

and that the number of individuals who have been infected with COVID-19 combined with the number of vaccinations could bring the community closer to the herd immunity target percentage; whereupon, he and Mr. Burton responded to queries by the members regarding the following topics:

- Administration of the second dose of the vaccine
- May 25, 2021 as the target date to have 50 percent of county residents vaccinated
- Mask ordinances in nearby counties
- Death rates over the past month
- Differences between influenza and COVID-19 testing

Mr. Burton indicated that a University of South Florida report which has been provided to the Commission contains recommendations from both the CDC and the World Health Organization and discusses the impact of masks in schools and in the community; whereupon, Dr. Choe provided an overview of the report, noting that the report concluded that if social measures to combat COVID-19 transmission are removed too early, the risk of a surge in COVID-19 infections would be greater.

Dr. Choe discussed the document developed by County staff regarding masks and indicated that it provides county-by-county statistics for those counties with mask mandates and those without, and related that studies show that school districts without mask policies have higher COVID-19 student infection rates than school districts with mask policies.

In response to queries by the members, Dr. Choe, with input by Emergency Services Medical Director Dr. Angus Jameson, discussed the link between COVID-19 and mental health disorders, and provided information regarding the monitoring of variants, hospital bed availability, and hospital staffing shortages.

Mr. Burton indicated that the earliest date that the mask ordinance could be placed on the agenda for discussion is May 11, 2021; whereupon, Chair Eggers called for a break prior to the Commission discussion.

In response to queries by Chair Eggers, Mr. Burton provided an overview of the Local State of Emergency (LSE), indicating that it allows the County to be reimbursed through the Federal Emergency Management Agency; and that it is separate from any statewide state of emergency; whereupon, he discussed his order requiring organizations who host large events to have approved safety plans in place.

Attorney White provided an overview of the impetus behind the creation of the mask ordinance and discussed statutory requirements related to the passage of emergency ordinances and regular ordinances. She discussed Governor Ron DeSantis's decision to remit the fines of individuals and businesses who violated local restrictions regarding COVID-19.

**A motion was made by Vice-Chair Justice, seconded by Commissioner Seel, that the order extending the Local State of Emergency be approved. The motion carried by the following vote:**

Resolution No. 21-20 adopted extending the Local State of Emergency established in Resolution No. 20-16 until 3:00 P.M. on April 23, 2021.

The Commissioners, with input by Attorney White and Mr. Burton, discussed the following topics:

- Decorum when addressing the Commission
- Statistics related to vaccinations, mask mandate effectiveness, and COVID-19 infection rates among those with comorbidities
- Information regarding COVID-19 treatment, the lifting of mask restrictions, and the development of scientific research
- Suicide and overdose rates in 2020
- Exemptions in the mask ordinance for children and outdoor spaces
- Options for changes to the mask ordinance, including full repeal or partial repeal

During discussion, Commissioner Long expressed reservations regarding holding a public hearing on the mask ordinance in May, indicating that she believes the Commission should err on the side of caution and provide Dr. Choe, scientists, and universities more time to evaluate the effects of changing policies on COVID-19 rates.
