OMB has no objection to the Department of Safety and Emergency Services submitting a grant application to the Department of Justice, Public Safety Partnership and Community Policing Grants Program.

The requested funds are for replacement of the existing independent computer-aided dispatch (CAD) and records management systems and implement a new shared, integrated CAD system to ensure the dispatch of an appropriate emergency response to telephone calls placed to 911.

This is a multi-year reimbursement grant project that will likely impact FY22-FY24. The requested funding is \$1,750,000 with no expected match. The total project is estimated to cost \$1,750,000.
