OMB has no objection to the department submitting a grant application to the US Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP), to obtain funding to enhance services of the County's existing family dependency treatment court program.

Requested funding is \$900,000 from the OJJDP FY 2018 Drug Treatment Courts Program. A 25% match is required, \$300,000. No County funds will be used for the match. The match will consist of eligible court expenses. Total project cost is estimated to be \$1,200,000. The grant period is 48 months or 4 years.

**Proposed Abstract (Project Scope of Work):** This Grant Application requests funding for the Drug Treatment Courts Program operated by the Sixth Judicial Court. This project will overlap the existing OJJDP grant we have to support the Family Dependency Treatment Court for the first year and then extend the project for an additional three years. The Family Dependency Treatment Court will continue to serve an estimated 35 parents per year and offer outpatient counseling and residential treatment. Starting in the first year they will enhance existing services by adding recovery housing and peer recovery coaching to help navigate clients with obtaining housing, employment and other recovery support services. The population of focus will be parents involved in dependency proceedings who have mental health and substance abuse issues, including opioid use.

**Benefit Summary (How will this benefit the County, Dept, etc?):** Drug Treatment Courts Program exist to provide participants supports to help them overcome their substance abuse issues and the opportunity to become productive, drug free members of the community. The participants of the Family Dependency Treatment Court will be parents involved in dependency proceedings who have mental health and substance abuse issues. This program strives to reduce the impact of substance abuse and mental health on the entire family, especially considering the recent opioid epidemic.
