This item is for the approval and execution by the County Administrator of an Employment Sites Program (ESP) Funding Agreement for a sum of not-to-exceed \$1,645,000.00 to renovate a 35,080-square-foot former pharmaceutical building

The Board of County Commissioners (BCC) approved funding for the Pharmetric Laboratory, LLC for the Pharmetric Laboratory Expansion on July 22, 2025, in the amount of \$1,645,000.00. The BCC also authorized the County Administrator to execute and negotiate all terms and agreements in relation to this project (Granicus Item 25-0952A).

The project site is located at 7265 Ulmerton Road, Largo, FL. The project will result in the rehabilitation of an existing 35,080 square foot industrial building. The County portion requested is for retrofits to convert the existing non-sterile space into a sterile manufacturing space.

This item is for the execution of the Employment Sites Program (ESP) Funding Agreement with Pharmetric Laboratory, LLC. The agreement is issued in the amount of \$1,645,000.00 for a contract period of 20 years from the effective date. The County will pay Pharmetric Laboratory, LLC following the receipt of the Certification of Completion/Occupancy of the building renovations.

The total requested County contribution for this project is \$1,645,000.00. Including this item, the total amount of Penny IV affordable housing funds committed is \$44,596,765.00 out of the \$98,000,000.00 currently estimated in all ten years of Penny IV.

Funding for this project is included in the FY25-FY30 Capital Improvement Program under the Economic Development Capital Projects (project 004149A). This project is funded by Local Infrastructure Sales Surtax (Penny for Pinellas), as part of the 8.3% countywide investment for Economic Development and Housing, half of which, or 4.15%, is set aside for Economic Capital Projects specifically.

The Economic Development Capital Projects (project 004149A) has a FY25 Budget of \$25,183,000.00. FY25 Expenditures are estimated at \$9,381,306.00.
