Then, in the gate area, people were ignoring in some areas the signs on seats to not sit in certain seats. There was probably 10-15% compliance with mask wearing. I shot video at 6:30 a.m. and at 6:45 a.m. I was with my parents, one 79 years old and the other 81 years old, with a heart condition. I was very, very upset and worried about the lack of people trying to adhere to CDC guidelines. I realize that the county government cannot "police" all areas at all times of day, even if there were a mandate. But, I feel a mandate would help. Cases are rising in the greater Tampa bay area. I am a resident of Riverview, FL, but I frequent Pinellas Co. for shopping, eating and swing dancing. I have a lot of friends who reside in Pinellas Co. I am a home health nurse and I am worried. A family member of one of my patients is showing COVID-19 symptoms. I was there last Friday. Studies have shown people are the most contagious BEFORE they start showing symptoms so all the symptom check screening calls we do are of little value. And we are only allowed to use our limited supply of N95 masks for lab confirmed cases. Was i exposed? Will i give it to my other patients and my high risk partner?
