Since 2003, our program has utilized waterfront boat lifts at this location to support our mission-driven, water-based initiatives. The two skiff lifts provide vital access to the Lower Tampa Bay region and are essential to our daily operations.

Due to their age and damage sustained during recent hurricanes, one lift is now inoperable and the second is at risk of failure. Immediate replacement of both lifts is critical to ensure the continuation of our water-based activities and the success of our environmental programs.

Tampa Bay Watch has secured permits from the U.S. Army Corps of Engineers (ACOE), the Florida Department of Environmental Protection (FDEP), and Pinellas County to maintain waterfront depths and replace the classroom boat and lift, with completion expected by November 2025. To fully rehabilitate our waterfront operations, we are requesting MSTU funds to replace two aging skiff lifts while utilizing the existing pilings. A professional structural analysis has confirmed that the pilings remain sound; only the lifting hardware requires replacement.

This project addresses a critical operational gap. The current skiff lifts—essential for deploying shallow-water vessels used in environmental restoration and education—have deteriorated due to age and storm damage. One lift is inoperable, and the second is at risk of failure. Without replacement, Tampa Bay Watch's ability to conduct water-based programs, including habitat restoration, marine debris removal, and youth education, will be severely compromised.

To ensure cost-effective implementation, a Request for Proposal (RFP) was distributed to six boat lift companies. Three bids were received: Edge Marine submitted the lowest bid at \$23,000, followed by Pelican Lift Services at \$25,509 and Gulf and Bay Dock Works at \$26,409. Edge Marine has a proven track record with Tampa Bay Watch, consistently delivering high-quality services on time and within budget.

The scope of work includes installation of two 10,000-pound lifts, motors, gearboxes, control boxes with remotes, pulleys, winders, pipe, cable, and replacement bunks—essentially all components except the pilings. These upgrades will restore full functionality and ensure safe, reliable waterfront operations for the next 20 years.

Any costs exceeding the MSTU grant will be covered by the Spurlino Foundation or Tampa Bay Watch's operating

account, demonstrating strong financial stewardship and commitment to project completion. This investment will directly benefit the community by enabling continued access to environmental education, volunteer engagement, and coastal restoration efforts that support Pinellas County's strategic goals.

Program Outcomes: Describe the timeline by which the project will be implemented including short-term and long-term results. (Required) The replacement of the two skiff lifts at Tampa Bay Watch is scheduled for completion by the end of the calendar year. The project timeline is structured to ensure minimal disruption to ongoing waterfront programs and to restore full operational capacity as quickly as possible.

Short-Term Timeline and Results (0–3 months):

October-November: Edge Marine, the lowest qualified bidder, will be engaged to begin work immediately upon contract approval.

December: Installation of two new 10,000-pound skiff lifts using the existing pilings. This includes motors, gearboxes, control boxes with remotes, pulleys, winders, pipe, cable, and replacement bunks.

By Year-End: Full restoration of lift functionality, allowing uninterrupted access to Tampa Bay for shallow-water skiffs used in education, restoration, and monitoring programs.

Long-Term Results (1–20 years):

The new lifts will support Tampa Bay Watch's missiondriven activities for the next two decades, ensuring safe, reliable, and efficient vessel deployment.

Enhanced operational capacity will allow for expanded programming, increased volunteer engagement, and improved responsiveness to environmental restoration needs.

The investment will reduce maintenance costs and downtime, improving long-term resource efficiency and supporting the County's strategic goals of environmental stewardship, public service, and economic vitality.

This project ensures continuity of essential waterfront operations and reinforces Tampa Bay Watch's role as a trusted environmental partner in Pinellas County.
