SECOND AMENDMENT

This Amendment is made and entered into on the date last executed below ("Effective Date") by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and HR Green Inc., IA, hereinafter referred to as "Contractor," (individually referred to as "Party," collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on July 18, 2023, pursuant to Pinellas County Contract No. 23-0482-P (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide Building & Development Review On-Call Services for the County; and

WHEREAS, Section 10 ("Miscellaneous"), subsection B ("Amendment") of the Pinellas County Standard Terms & Conditions permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for overtime hourly rates at the same terms and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- The following hourly overtime rates are added to Exhibit D, Section 5 ("Building Services -Permit Technician - Hourly Cost") for the Permit Technician:
 - a) Time and half, defined as all hours worked in excess of eight (8) hours, up to and including 12 hours in any workday or more than 40 hours in one week, shall be paid at \$165.00 per hour.
 - b) Double time, defined as all hours worked in excess of 12 hours in any workday and for all hours worked in excess of eight hours on the seventh consecutive day in a workweek, shall be paid at \$220.00 per hour.
- 2. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
