SUBJECT: United States Environmental Protection Agency Section 105 Air Pollution Control Grant

DATE: July 12, 2024

The Environmental Management Division of Public Works is recommending the approval of the grant application to the United States Environmental Protection Agency. This grant application will provide additional funding to support the existing air pollution control program.

Public Works is requesting grant funding in the amount of \$748,880.00 for the project period fiscal years (FY) 2025 and FY 2026 (FY 2025 - \$355,410.00; FY 2026 - \$393,470.00). A match is required and estimated at \$1,747,386.00 (FY 2025 – \$829,290.00; FY 2026 - \$918,096.00). The grant is on a reimbursement basis. The source of the estimated total project costs of \$2,496,266.00 is the Environmental Management Division's Air Quality operating budgets for fiscal years FY 2025 and FY 2026.

Authority for the Director of Public Works to sign this grant application is granted under the County Administrator's delegation of authority dated March 28, 2016.
