Ground Water Return Wells at Public Safety Campus is an urgent capital project. The existing return wells were not built as designed, and as a result are causing high back pressure readings and will result in a total system failure if not re-built to meet design criteria. The General Fund transfers to the Capital Projects Fund will increase \$2,200,000.00 to fund capital project Ground Water Return Wells at Public Safety Campus (006192A). As a result, the General Fund Reserves (Contigency) will decrease \$2,200,000.00. The Capital Projects Fund will increase its transfers from the General Fund and allocate budget to Ground Water Return Wells at Public Safety Campus (006192A).

Furthermore, \$440,000.00 will be realigned from General Fund Reserves (Contingency) to Mid-County Operations under the Department of Administrative Services (DAS) for the purchase and installation of a fuel replenishment system for the generator at PSC. The genrator's fuel replenishment system failed in 2019 and a manual process was put into place in the interim. DAS has a procurement for a new system currently in Granicus (23-1649A) and requires these funds for procurement.
