A RESOLUTION OF THE PINELLAS COUNTY BOARD OF COUNTY COMMISSIONERS PRESENTING THE HONORARY DESIGNATION OF COUNTY ROAD 1 BETWEEN CURLEW ROAD AND TAMPA ROAD IN PINELLAS COUNTY AS "SERGEANT NICHOLAS A. FLOWERS MEMORIAL ROAD."

WHEREAS, Nicholas A. Flowers was born and raised in Pinellas County, FL and graduated from Palm Harbor University High School in 2003;

WHEREAS, Nicholas A. Flowers was an Army Intelligence Specialist and served in Iraq, Korea and Germany;

WHEREAS, Nicholas A. Flowers awards and decorations include: Meritorious Service Medal/Army Commendation Medal/Army Achievement Medal (5th Award)/Army Good Conduct Medal/Army Reserve Components Achievement Medal (2nd Award)/National Defense Service Medal/Korean Defense Service Medal Iraq Campaign Medal with Bronze Service Star/Global War on Terrorism Service Medal/Armed Forces Reserve Medal with M Device/Army Service Ribbon/Overseas Service Ribbon with Numeral 2/Army Reserve Components Overseas Training Ribbon/Combat and Special Skill Badge Basic Marksmanship Qualifications Badge with Marksman Rifle Bar/Overseas Service Bar;

WHEREAS, Nicholas A. Flowers, while on active duty, died April 5, 2018 in a traffic accident in Orlando, FL;

WHEREAS Nicolas A. Flowers was posthumously promoted to the rank of Sergeant as of April 5, 2018;

WHEREAS, Section 336.02, Florida Statutes empowers county commissioners to name roads and streets in unincorporated areas.

NOW THEREFORE, BE IT RESOLVED by the Pinellas County Board of County Commissioners, duly assembled on this _____ day of _____ 2026 as follows:

- Section 1. County Road 1 between Curlew Road and Tampa Road is hereby given the honorary designation as "Sergeant Nicholas A. Flowers Memorial Road."
- Section 2. The County Administrator, through his designated staff, is hereby authorized for placing, as deemed appropriate and in accordance with any applicable state or federal standards, signs identifying County Road 1 between Curlew Road and Tampa Road as having the honorary designation of "Sergeant Nicolas A. Flowers Memorial Road."
- Section 3. Nothing herein changes the official name of County Road 1 between Curlew Road and Tampa Road, notwithstanding the honorary designation.
