FIRST AMENDMENT

This Amendment is made and entered into this $\frac{6}{}$ day of $\frac{March}{}$ 20 $\frac{24}{}$ by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Site One Landscape Supply, LLC, Roswell, GA hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on March 28, 2023, pursuant to Pinellas County Contract No. 22-0657-B (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Herbicides, Aquatic Herbicides and Adjuvants for County; and

WHEREAS, Section Thirty Six ("AMENDMENT") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for renewal of the agreement for the contracted goods, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- In accordance with Section 6 ("Term of Agreement"), subsection B ("Term Extension"), the
 parties agree to exercise a twelve (12) month extension resulting in a new contract end
 date of March 27, 2025.
- Section 7 ("Spending Cap And Payment Structure") is revised to reflect an increase in the amount of Two-Hundred Ninety-One Thousand, Two-Hundred Eighty-One Dollars and Eight cents (\$291,281.08), for a new total not-to-exceed sum of Five-Hundred Eighty-Two Thousand, Five-Hundred Sixty-Two Dollars and Sixteen Cents (\$582,562.16).
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.
