FIRST AMENDMENT

THIS AMENDMENT is made and entered into this 6 day of April	, 2021, 1	by and
between Pinellas County, a political subdivision of the State of Florida, hereinafter the ("County"), for and or	ı behalf
of Visit St. Petersburg/Clearwater ("VSPC"), and Sunsets at Pier 60 Society, Inc., a Florida not fo	r profit corp	oration
("Event Organizer") (collectively, the "Parties," or individually, a "Party").		

WITNESSETH:

WHEREAS, the County and Event Organizer entered into a Tourism Promotion Agreement on January 28, 2020 (hereinafter "Agreement"), pursuant to which Event Organizer agreed to promote and market Pinellas County tourism in connection with the Pier 60 Sugar Sand Festival ("Event") and County agreed to pay Event Organizer a Sponsorship Fee; and

WHEREAS, the Event Organizer did promote and market the destination in support of Pinellas County tourism; and

WHEREAS, through no fault of the Event Organizer the event was cancelled due to the widespread pandemic known as Coronavirus; and

WHEREAS, the County now wishes to modify the Agreement and the Event Organizer agrees to same in order to reimburse the actual dollars spent in promoting the destination prior to the event cancellation; and

WHEREAS, Section 2C of the Agreement provides for modification and payment of the Sponsorship Fee on revised terms by mutual written agreement of the parties; and

NOW THEREFORE, the Parties agree that as provided in Section 2 of the Agreement, the terms therein are revised and amended as follows:

- 1. The County agrees to reimburse the Event Organizer the total sum of Thirty-Five Thousand Dollars (\$35,000.00) as an Event sponsor, for benefits received by the County for the promotion and marketing of Pinellas County tourism by Event Organizer in connection with the Event as defined in the revised promotion program described in Exhibit A attached hereto and made a part hereof.
- 2. Modifications above shall be effective as of the date of this Amendment and continue through July 31, 2021.
- 3. Except as changed or modified herein, all provisions and conditions of the original Agreement shall remain in full force and effect.
