

INTERLOCAL AGREEMENT AMENDMENT 1

This is an amendment to the current Interlocal Agreement entered into by and between the BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, Florida (hereinafter "COUNTY") and BOB GUALTIERI, as Sheriff, Pinellas County, Florida (hereinafter "SHERIFF"), dated August 24, 2016.

It is the intent of the parties herein to amend the above-described Agreement with all terms and conditions of said Agreement remaining the same except as provided herein below:

1. Page 3, Section II, Obligations of the Sheriff, Paragraph Number 1 shall read:

The SHERIFF hereby agrees to provide seven (7) deputy sheriffs who shall be assigned on a full-time basis to the Airport, with said deputies scheduled so that at least one (1) deputy sheriff is on duty per shift covering the twenty-four (24) hours per day, seven (7) days per week period of operation and who shall be continuously present on Airport property. Effective June 1, 2017, the SHERIFF further agrees to provide an additional five (5) deputy sheriffs to further augment the current staffing level for a total of twelve (12) deputy sheriffs. This staffing model will provide two (2) or more deputies per shift with additional coverage scheduled to coincide with the busier times at the Airport. The parties agree that work schedules may be altered from time to time to adjust to changes in flight schedules or other needs as determined by the SHERIFF and the COUNTY but an effort will be made to change the schedules of individual deputies no more often than necessary. Each deputy assigned to the Airport facility shall be a fully certified law enforcement officer, as provided in Florida Statute 943.1395, authorized to affect arrests and carry firearms, and be in uniform. The deputies assigned to the Airport must have at least two (2) years of experience in law enforcement and it is desirable that such deputies have traffic and criminal investigation experience. It is also desirable that the deputies assigned to the Airport have aviation-related experience. The SHERIFF shall equip each deputy providing service under this Agreement with a complete uniform, marked patrol vehicle and all other necessary and appropriate equipment.

2. Page 4, Section II, Obligations of the Sheriff, Paragraph Number 2.a. shall read:

Respond to the passenger screening checkpoints located at the Terminal Building within five (5) minutes when summoned by TSA via the approved methods outlined in the Airport Security Program. Sheriff's deputies shall take appropriate action whenever a passenger is found to be in unauthorized possession of any weapon or explosive. However, the SHERIFF shall not be responsible for the screening of passengers or luggage or for the implementation of any other security programs

which are the responsibilities of the air carriers as such is more specifically set forth in Title 49 of the Code of Federal Regulations, Parts 1544 & 1546.

3. Page 4, Section II, Obligations of the Sheriff, Paragraph Number 2.c. shall read:

Perform routine vehicle patrol of Airport properties outside the SIDA and within the AOA when no airline passenger screening is underway.

4. Page 4, Section II, Obligations of the Sheriff, Paragraph Number 2.d. (new) shall read:

When requested and available, assist by staffing the exit lane portals from the sterile hold room areas for gates 7-11.

5. Page 4, Section II, Obligations of the Sheriff, Paragraph Number 2.e. (new) shall read:

Perform routine foot patrol of airport curbside and assist Airport Traffic Assistants.

The remainder of the subparagraphs in Section II., Obligations of the Sheriff, Paragraph Number 2 shall be renumbered g. through i.

6. Page 5, Section II, Obligations of the Sheriff, Paragraph Number 5, shall read:

The SHERIFF shall make available to the Airport such other and ancillary law enforcement services as are generally available throughout the unincorporated areas of Pinellas County at no additional cost to the COUNTY.

7. Page 6, Section VI, Compensation, Paragraph Number 1 shall read:


During the term of this Agreement, the COUNTY shall pay to the SHERIFF, for the law enforcement services to be performed by the SHERIFF pursuant to the terms of this Agreement, the sum of SEVEN HUNDRED TWENTY-SEVEN THOUSAND NINE HUNDRED FIFTY-SIX DOLLARS AND SEVENTY-EIGHT CENTS (\$727,956.78). In addition, the COUNTY shall pay to the SHERIFF an additional sum of SIXTY-NINE THOUSAND TWO HUNDRED EIGHTY-FOUR DOLLARS AND TWELVE CENTS (\$69,284.12) for two of the additional five deputies being added June 1, 2017. Said sums shall be paid monthly in the amounts of SIXTY THOUSAND SIX HUNDRED SIXTY-THREE DOLLARS AND NO CENTS (\$60,663.00) for the months of October 2016 through May 2017, and SEVENTY-SEVEN THOUSAND NINE HUNDRED EIGHTY-FOUR DOLLARS AND NO CENTS (\$77,984.00) for the months of June 2017 through September 2017. Costs are detailed in the attached exhibits, Exhibit A and Exhibit B, which are incorporated

herein by reference. The cost of three of the additional five deputies added June 1, 2017, shall be borne by the SHERIFF.

Except as provided above, the terms and conditions of the Interlocal Agreement dated August 24, 2016, shall continue through September 30, 2017.


