1. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:

ORDINANCE OF THE COUNTY OF PINELLAS, PROVIDING THAT THE PINELLAS COUNTY CODE BE AMENDED BY REVISING CHAPTER 90 OF SAID CODE; PROVIDING FOR REVISIONS TO **CHAPTER 90 OF THE CODE INCLUDING REVISIONS TO SECTION 90-7 RELATED** TO SMOKING AND VAPING ON CERTAIN COUNTY OWNED PROPERTIES AND **BEACHES; AMENDING SECTION 90-16** RELATING TO BOATING, DOCKING AND STORAGE OF VESSELS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AREAS EMBRACED; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.
