THIRD AMENDMENT

This Amendment is made and entered into this ____day of _____ 2024, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Graybar Electric Company Inc., NY, hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County is authorized to procure goods and services based on the contract terms and pricing received by other governmental competitive solicitation processes which are made available to local public procurement units; and

WHEREAS, following a competitive procurement process, Omnia Partners entered into Agreement EV2370, with Contractor, effective February 1, 2018(the "Cooperative Procurement"); and

WHEREAS, the County elected to utilize the resulting contract terms and pricing of the Cooperative Procurement; and

WHEREAS, the County and the Contractor entered into an agreement on January 12, 2018, pursuant to Pinellas County Contract No. 178-0181-PB (hereinafter "Agreement") pursuant to which the Contractor agreed to provide electrical, lighting, data communications, and security products for the County; and

WHEREAS, the County is exercising the second term extension, in conjunction with the renewal of contract (178-0181-PB electrical, lighting, data communications, and security products and services); and WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide

for a term extension, and an increase to the contract value, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- The Parties agree to extend the Agreement an additional four years from January 31st,
 2025 to January 31st, 2029, in conjunction with the cooperative procurement.
- 2. The total not-to-exceed expenditure is revised to reflect an increase in the amount of \$1,464,000.00, for a new total not-to-exceed amount of \$5,494,000.00.
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.
