This contract amendment allows for additional services for plan participants to receive physical therapy services remotely at no additional administrative fee to Pinellas County. The cost for services will be processed as claims in the same manner as traditional physical therapy and be limited to \$250.00 per year for 'Acute' patients and \$995.00 for 'Chronic' patients. These fees replace the costs of traditional physical therapy, which can range into the thousands of dollars.

The Provider, Hinge Health MSK, guarantees a return-on-investment (ROI) of 1.5x as stated in the amendment.

Funding for this service is in the Employee Health Benefits Fund and is included in the FY23 Adopted budget and FY24 Request.
