Description & Comments

The agreement is with the Homeless Emergency Project, Inc. d/b/a Homeless Empowerment Program. The agency is located at 1120 North Betty Lane, Clearwater, FL. The agency will assist eligible homeless or at-risk homeless with rental payments, move in costs, and security/utility deposits through the County's Community Housing Assistance Program (CHAP). The agency is a sub-recipient of the County's Emergency Solutions Grant allocation. The agreement starts October 1, 2016 and ends September 30, 2018.

The County's Community Housing Assistance Program (CHAP) began providing short-term rental and utility assistance for homelessness prevention and rapid re-housing activities in fiscal year 2012-2013. The County has partnered with "three community agencies" (from Action Plan) to administer the CHAP program: Homeless Emergency Project, Catholic Charities Diocese of St. Petersburg, and the Pinellas County Housing Authority. However, it appears that the County only has agreements with two of the agencies: Homeless Emergency Project and Catholic Charities Diocese of St. Petersburg.

Comments:

Please explain more clearly in the staff report that the funds are pooled funds for the CHAP program and are not committed to this agency only.

The County currently has agreement ESG15HEP with an agreement period from October 1, 2015, to September 30, 2017. From my understanding the existing agreement does not include the \$16,612.00. This FY16 set aside is being reallocated within program constraints; and therefore only needs to be included in the new agreement for the funds to be spent.
