### Description & Comments

A request for approval for the Utilities Director to accept the Notice of Award, including all terms and conditions, from the U.S. Environmental Protection Agency (EPA) Community Grants – Sustainable Water Infrastructure Program for the Pinellas Park Interceptor Collection System Improvements Project 003147A.

The County received a congressional appropriation for this project in the FY 2022 federal Consolidated Appropriations Act (P.L. 117-103), which includes drinking water, wastewater, stormwater infrastructure, and water quality protection projects.

No signature is required to accept this award. The County accepts this award by either drawing down funds within 21 days after the EPA award is delivered, or not filing a notice of disagreement with the award terms and conditions within 21 days after the EPA award mailing date of February 20, 2025.

The grant funds will be receipted to Pinellas Park Interceptor Collection System Improvements Project 003147A, included in the FY25-30 Capital Improvement Plan (CIP). The grant funded expenditures and corresponding revenue is budgeted in the CIP in the amount of \$700,000.00 in FY25. A 20% match of \$175,000 is required. The County may charge for reimbursement of allowable cost incurred after July 1, 2024 and before 9/30/2025.
