Good Afternoon Commissioners:

I had the opportunity to watch the county commission meeting via YouTube this morning. I am writing in support of naming the Pinellas County Justice Center after the late Bernie McCabe. Having been both an employee of his and adversary of his office after entering private practice, I believe it is appropriate to name the building after Mr. McCabe. Mr. Bartlett noted that a large number of judges started their careers as prosecutors. I write to add that in addition to judges, a large number of the top trial lawyers in the area cut their teeth trying cases for Mr. McCabe in the Sixth Judicial Circuit. I also think it's worth noting that, to my knowledge, he personally handled the prosecutions of every homicide case in which a police officer was murdered.

On a personal level, I can also tell you that Mr. McCabe was very understanding of the importance of family and having an appropriate work-life balance. When our youngest was born very premature and had a 6-week NICU stay in Orlando, Mr. McCabe was very concerned for our well-being and accommodating to the many trips that my wife (one of his Assistant State Attorneys) needed to take on I-4 during those six weeks.

In sum, Mr. McCabe is known for being our circuit's top prosecutor – but his legacy is much bigger than the office he held. I appreciate your thoughtful consideration of naming the 49th Street Courthouse after Mr. McCabe.

Dear Chairman Eggers,

We write you today to formally request, pursuant to the County's building naming policy, that the *Pinellas County Justice Center* on 49th Street in Clearwater, often referred to as "the CJC," be renamed after our late State Attorney Bernie McCabe.

As you know, last week Mr. McCabe passed away after 48 years of service to the people of Pinellas and Pasco County. His passing marks the end of an illustrious career of service that dates back to 1972. In those 48 years, including 28 years as State Attorney, he left an unrivaled legacy in the pantheon of Florida justice seekers.

As a boss, friend, and mentor to thousands of lawyers over the years; a zealous advocate on behalf of victims and their families; and a warrior for the families of slain police officers, Bernie McCabe has left an indelible mark on the lives of so many.

Mr. McCabe's pursuit of justice in the halls of criminal courthouses in Pinellas and Pasco County would be enough to fill the volumes of libraries, but it was not enough to satisfy his desire to serve. He cared deeply for children and families. It is why for years, he served faithfully as a member of the Pinellas County Juvenile Welfare Board, as a board member for the YMCA of the Suncoast, and was the only State Attorney in Florida to seek to advocate on behalf of children in dependency cases.

That yearning to serve in new and innovative ways never dimmed, which is why he was one of the first State Attorney's in Florida to start a Drug Treatment Court to better serve the addicted and downtrodden, and why he was the first to create a Veterans Treatment Court. He could be fierce when he needed to be, but his heart was one in constant search of truth and righteousness.

Over the years, many people sought him out. Some came seeking justice, others mercy. Many came to seek his counsel on their careers or public policy. His advice was thoughtful, forward thinking, with a deep understanding of the past and an eye to the future. The loss of that counsel will leave a hole in our community and our state that will be tough to fill.

Whether it was as our elected State Attorney, through his service on boards including a lengthy term as Chairman of Florida's Violent Crime and Drug Control Council, as past president of the Florida Prosecutor's Association, and on the transition team of numerous Florida Attorney Generals, Mr. McCabe's legacy extends far beyond the borders of the Sixth Circuit. But we get to claim him as our own, and that is our unique distinction.

Mr. McCabe was fond of asking his young prosecutors when they asked him what they should do on a case, "What is the right thing to do?" He had a way of making complex decisions easy with keen moral clarity.

It is hard to honor the legacy of someone who has done so much for so long. The naming of a building does not do that, only the good deeds of those whose lives he impacted can truly steward his legacy. But naming the building that he walked into everyday to serve as a minister of justice, well...it's the right thing to do. We hope you will.





Dear Pinellas County Commissioners,

Pinellas County has lost one of its stalwarts of public service with the passing of State Attorney Bernie McCabe. As a voice for our citizens, particularly victims of crime, in the courtroom for well over three decades, Bernie was firm but fair. I worked early in my career in the State Attorney's Office as the first African American Assistant State Attorney in the Sixth Circuit. It is my recommendation that the Pinellas County Justice Center be renamed after Bernie McCabe, Pinellas-Pasco State Attorney.

No doubt Bernie could have chosen a different career path, one that involved the allure of a productive private practice, but he chose to serve our county and its citizens in what some would call an unpopular position. Bernie shouldered the mantle of that responsibility with his characteristic decisiveness and a steadfast hold on the rule of law.

I was once prosecuted by Bernie for my protesting the sale of drug paraphernalia. Even though Bernie was firm in his prosecuting me for trespass and the jury convicted me, it was a fair prosecution and the judge imposed a fair sentence.

As president of the St. Petersburg Branch of the NAACP, I recognized two Assistant State Attorneys, Richard Riplinger and Magda McSwain and honored them for their work in ridding the black community of serious crimes. They were our partners in Justice, in fighting the spike of black on black murders at the time. Being a prosecutor is among the noblest of professional endeavors.

He was a mentor to many inside and outside the practice of law, with accountability being the hallmark of his tutoring. Nothing was spared when it came to assisting the homeless, children-at-risk, veterans, or protecting law enforcement. Our legal and nonprofit community will be impacted by his mentoring and guidance for decades to come.

I write to add my name to the chorus of people asking that the Pinellas County Criminal Justice Center be renamed in the honor of Bernie McCabe.

I count myself among the lucky to have gotten to know and work with Bernie. In 1991, he spearheaded a program at the Pinellas State Attorney's Office to increase the minority representation in the office. His efforts included appointing two attorneys to lead the program. Those attorneys traveled to Atlanta to attend the Southeastern Minority Job Fair, a job fair that brings law firms from all over the country to meet and interview law students for the purpose of employment. By the fall of 1991, five African American lawyers and one Asian American lawyer were hired as Assistant State Attorneys. Two of those lawyers became judges, one became an Assistant United States Attorney and two others work in very successful private civil litigation firms. His efforts did not stop there. Each year for the next 10 or so years, he sent representatives to the jobs fair to find other qualified minority attorneys. For three years, he assigned me to serve as one of the recruiters. It was a very serious and deliberate effort at fostering diversity. Numerous African American and other minority lawyers in Pinellas County and around the state of Florida owe their start in the practice of law to the efforts of Bernie McCabe.

In 1993, Bernie McCabe collaborated with Vyrle Davis of Pinellas County Schools to encourage the black males working at the State Attorney's office to serve as mentors. The School Board was in the throes of implementing the 500 Role Models of Excellence Project in Pinellas County Schools. The design of the project was to get African American male professionals to go into the Pinellas County Schools and serve as mentors and role models. Bernie approached each of the African American male attorneys in the office and asked us to participate in the project. Participation in the program took place during work hours. Bernie understood that and felt it was a worthy cause. For the next 17 years, I continued to serve as a mentor. I believe I made a difference and Bernie deserves credit for getting me involved.

In 2001 Bernie was awarded the "Pursuit of Excellence" award by the Fred G. Minnis Bar Association for his commitment to diversity and his efforts making sure that qualified African American lawyers were hired into the Sixth Circuit State Attorney Office. The Fred G. Minnis Bar Association is a voluntary bar association named in honor of the first African American Lawyer in Pinellas County. In presenting the award, the presenter also recognized Bernie for encouraging members of his staff to serve in the community.

Bernie McCabe's North Star has always been doing the right thing. It is what he told his lawyers, and it is the way he reviewed cases brought before him. On three occasions that I am familiar with, a former defendant who had been convicted once in their lifetime many years earlier petitioned the State Attorney's Office to have the conviction removed from their record. In each occasion, a person had been convicted of a crime that was clearly out of character. Otherwise, that person led an exemplary life. For whatever reason, he or she wanted that charge and conviction removed from their record. In each occasion, recognizing that the conviction had been an anomaly, Bernie had his lawyers approach the court and asked the court to set aside the conviction. After the conviction was removed, the state then dismissed the charges and the arrest and conviction were expunged from the record. On one occasion in particular, a single mother had been convicted of misdemeanor child neglect some twenty years earlier. It was the only criminal history she had in all her years. By the time she petitioned Mr. McCabe to set aside the charge, both of her children were college graduates. The petitioner wanted people to know she was a good mother and did not want this stain on her record. Bernie McCabe agreed that it was the right thing to do.

I have had the pleasure of serving as a member of the judiciary since 1997. At the time of my appointment to the bench there was only one other African American member of the judiciary in all of the Sixth Circuit. It was Bernie McCabe who suggested that I submit my name for this post as soon as I became eligible. It was Bernie McCabe who lobbied for my appointment to the bench. It is to Bernie McCabe that many of us owe a debt of gratitude for all that he did to affect the lives of African American lawyers in particular and the African American community in general. His foresight and his commitment will have a lasting impact. I ask and urge you to rename the Pinellas Criminal Justice Center to honor the legacy of Bernie McCabe because it is the right thing to do.


Dear Chairman Eggers,
