The County consents to the assignment of this Agreement to SJ Electro Systems, LLC dba ICON Technologies

- SJ Electro Systems LLC, dba ICON Technologies agrees to perform, assume, and be bound by all rights, obligations, and provisions of the Agreement and any amendments thereto.
- SJ Electro Systems, LLC dba ICON Technologies hereby agrees to perform and assume all rights, duties, and obligations under the Agreement.
- The Contractor's name in the Agreement and all references thereto, are hereby amended from "ICON Supply, Inc. dba ICON Technologies" to "SJ Electro Systems, LLC dba ICON Technologies".
