

### THIRD AMENDMENT

This Amendment is made and entered into on the date last executed below (“Effective Date”), by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as “County,” and US Submergent Technologies LLC, located in Orlando, Florida hereinafter referred to as “Contractor,” (individually referred to as “Party”, collectively “Parties”).

#### WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on August 24, 2021, referred to as Pinellas County Contract No. 21-0360-B-BW (hereinafter “Agreement”), pursuant to which the Contractor agreed to provide Grit Removal Services for the County; and

WHEREAS, Section 21 (“Amendment”) of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to exercise a term extension and provide for an increase to the contract value, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

1. The Parties agree to exercise the first term extension and extend the term of the Agreement an additional twenty-four months from August 23, 2026, to August 23, 2028, in accordance with section 4 (“Term of Agreement”), subsection B (“Term Extension”) of the Agreement.
2. The current total not to exceed amount of \$2,226,220.00, as stated in Section 5 (“Compensation and Method of Payment”), subsection B, is revised to reflect an increase in the amount of \$1,320,000.00, for a new total not to exceed sum of \$3,546,220.00. In no event will the annual expenditure exceed \$506,602.86 in any given fiscal year without a written amendment to the Agreement.
3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.

IN WITNESS WHEREOF the Parties herein have caused this Third Amendment to be executed by their undersigned officials, who are duly authorized to bind the Parties to the Amendment.


