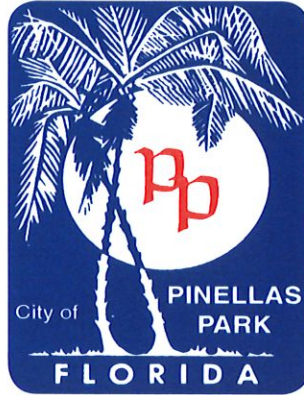

Dear Mr. Washburn:

In response to the Pinellas County letter dated May 17, 2017 regarding 126<sup>th</sup> Avenue N., Scherer Drive and 34<sup>th</sup> Street N., the City of Pinellas Park grants permission to Pinellas County to construct a trail within the Scherer Drive right-of-way between 28<sup>th</sup> Street N. and 34<sup>th</sup> Street N. The 126<sup>th</sup> Avenue N. right-of-way between 34<sup>th</sup> Street N and U.S. HWY 19 N. and the 34<sup>th</sup> Street N. right-of-way between Scherer Drive and 126<sup>th</sup> Avenue N. have been transferred to Pinellas County since the original request. As noted in the letter, Pinellas County would be responsible for the design and construction costs and future maintenance of the trail segments. Prior to construction, an interlocal agreement would need to be in place.

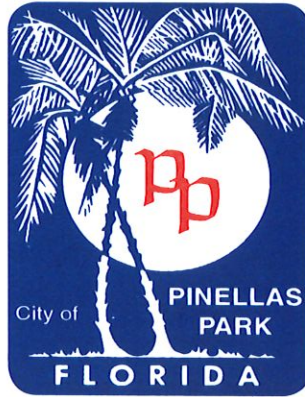
