# NOTICE OF PUBLIC HEARING PROPOSED AMENDMENTS TO THE PINELLAS COUNTY LAND DEVELOPMENT CODE

The Pinellas County Board of County Commissioners proposes to adopt the following Ordinances amending the Land Development Code.

A public hearing on the Ordinances will be held on **Tuesday, December 16, 2025, at 6:00 P.M.** or as soon thereafter as may be accommodated by the completion of the rest of the Board agenda, in the Palm Room, 333 Chestnut Street, Clearwater, Florida 33756. Members of the public wishing to address the body are encouraged to attend in person, but may also attend virtually utilizing Communications Media Technology (CMT) on the Zoom platform or provide comments in advance.

To address the County Commission in person, members of the public are encouraged to preregister at <a href="https://comment.pinellas.gov">https://comment.pinellas.gov</a>. Preregistration is encouraged but not required if individuals plan to attend the meeting at the Palm Room. Those who have not preregistered may register in person when they arrive.

Members of the public wishing to address the body virtually via Zoom or by phone are required to preregister by 5:00 P.M. the day before the meeting by visiting <a href="https://comment.pinellas.gov">https://comment.pinellas.gov</a>. The registration form requires full name, address and telephone number if joining by phone, along with the topic or agenda item to be addressed. Members of the public who cannot access the registration form via the internet may call (727) 464-3000 to request assistance preregistering. Only members of the public who have preregistered by 5:00 P.M. the day before the meeting will be recognized and unmuted to offer comments. If a member of the public does not log in with the same Zoom name or phone number provided in the registration form, they may not be recognized to speak. In person appearances for comment, or advance comments as noted below, are preferred. The County will use its best efforts to facilitate virtual comment, but citizens using technology to comment virtually are cautioned that this mechanism is being offered by the County as a courtesy and the County does not guarantee the proper functioning of technology involved.

### A. PROPOSED ORDINANCES AMENDING THE PINELLAS COUNTY LAND DEVELOPMENT CODE:

#### a. LDR-25-01 (Chapter 138 & 154 – Plats)

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA, AMENDING CHAPTER 138, ARTICLE II AND CHAPTER 154, ARTICLES I AND V; AMENDING GENERAL REVIEW AND APPROVAL PROCESSES; PROVIDING FOR THE ADMINISTRATIVE APPROVAL OF PLATS IN ACCORDANCE WITH STATE LAW; REQUIRING THE APPROVAL AND RECORDING OF A FINAL PLAT PRIOR TO THE ISSUANCE OF A CERTIFICATE OF OCCUPANCY OR THE SALE OF A BUILDING OR STRUCTURE LOCATED ON A PARCEL TO BE PLATTED; ESTABLISHING AND DEFINING MINOR SUBDIVISIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE LAND DEVELOPMENT CODE; PROVIDING FOR SCRIVENER'S ERRORS; AND PROVIDING AN EFFECTIVE DATE.

#### b. LDR-25-02 (Chapter 138 & 166 – Trees)

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA, AMENDING CHAPTERS 138 AND 166 OF THE PINELLAS COUNTY LAND DEVELOPMENT CODE; PROVIDING FOR AND AMENDING THE REGULATION OF TREES AND LANDSCAPING; AMENDING PROVISIONS RELATED TO NUISANCE SPECIES AND INVASIVE SPECIES; AMENDING PLANT MATERIAL SPECIFICATIONS; AMENDING NON-RESIDENTIAL AND MULTI-FAMILY LANDSCAPING STANDARDS; AMENDING THE APPROVED SPECIES LIST; PROVIDING FOR SEVERABILITY; PROVIDING AND AMENDING DEFINITIONS; PROVIDING FOR INCLUSION IN THE LAND DEVELOPMENT CODE; PROVIDING FOR SCRIVENER'S ERRORS; AND PROVIDING AN EFFECTIVE DATE.

In review of the Ordinances above, there may be modifications that arise at the public hearing and/or with other responsible parties. Certain matters heard by the Board of County Commissioners are quasi-judicial in nature. Please note that only competent, substantial, fact-based testimony or evidence may be considered by the boards in deciding the matters before them. Pure speculation or opinion, not based on competent facts, cannot be legally considered by the boards. Lay testimony with fact-based support (including but not limited to meeting minutes, surveys, engineering reports, etc.) may be considered competent and substantial evidence. Please note the County Attorney's Office represents and advises the Board and County staff but cannot give legal advice to the applicant or other interested parties.
