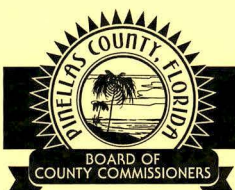

Dear Mr. Toner,

I am writing you in response to your submission of a Preliminary Site Information Questionnaire for the Tamarac by the Gulf Historic District. After reviewing the documentation, we find that this district is eligible for listing in the National Register of Historic Places (NR) under Criterion A for its significance at the local level as a mid-century planned retirement community. It is also eligible for listing under Criterion C at the local level for its well-maintained deed-restricted Ranch houses. Its period of significance would begin in 1967 and end in 1971, years in which the houses were initially planned, built, and sold. Please see enclosed information regarding the National Register registration form, NR process, the criteria for listing, and the results of listing.

The next step is the preparation of a National Register form. The instructions for completing the form are available online as National Register Bulletin 16: How to Complete the National Register Registration Form, <https://www.nps.gov/nr/publications/bulletins/nrb16a/>. I will be available to assist you in the process of preparing the nomination.

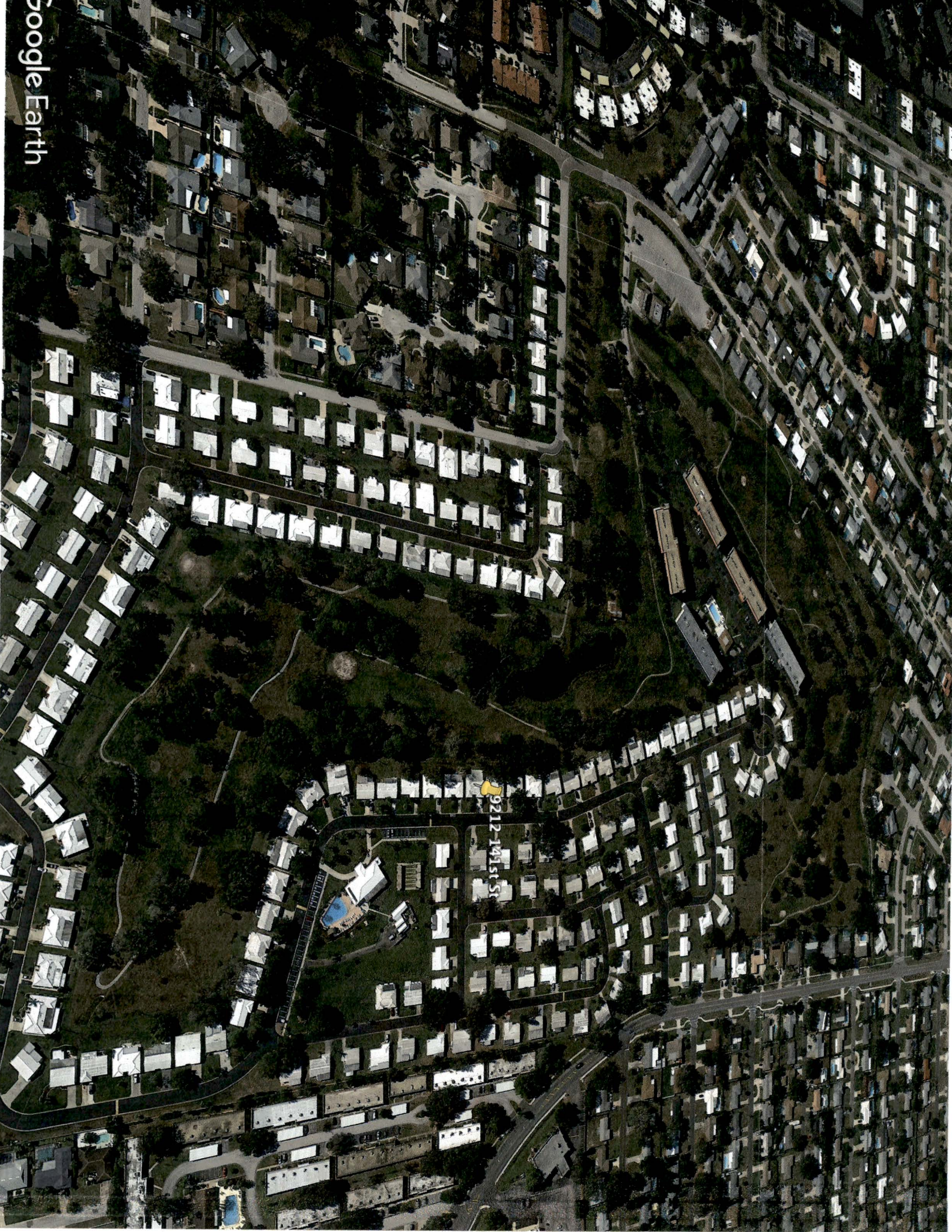
