Proclamation presented to Craig Hare, Director of EMS and Fire Administration. Mr. Hare recognized Chris Collins, Nick Eberhardt, and Eric Fayad as Paramedic of the Year, Emergency Medical Technician of the Year, and Emergency Medical Dispatcher of the Year, respectively, and on behalf of Pinellas Federal Credit Union, Vice President of Administration Gina Signor presented a \$100 gift certificate to each award winner.

Emergency Medical Services Advisory Council Chairman, City of Madeira Beach Mayor Travis Palladeno, with input by Mr. Hare, conducted a PowerPoint presentation, a copy of which has been filed and made a part of the record, and provided history of the Council. He discussed the nature of its membership and current work, noting that as tourism grows, the number of emergency transports increases.

Responding to queries by the members, Mr. Hale stated that the increase in transport calls is no longer seasonal; that planning for the future includes ensuring the county's hospitals maintain capacity for the increased need; and that three areas of lapsed coverage in the county have been identified and are being addressed. Mayor Palladeno thanked the Board and staff for their strong support of the services that maintain a top level of care within the county, and the members collectively expressed their appreciation for all the men and women who serve.

**10. Ordinance amending the Countywide Rules regarding Target Employment Centers, Transferable Development Rights, and Temporary Lodging Intensity Standards (first hearing).**

Responding to a request by Commissioner Morroni, Pinellas Planning Council Planning Division Manager Michael Crawford related that the Target Employment Center category was adopted in August 2015 as part of the updated Countywide Plan; and that the centers identify larger, employment based areas which allow for a higher floor area ratio. He noted that originally the centers were limited to 100 acres or greater; that the City of St. Petersburg has requested a reduction of the requirement to 10 acres; and that the Pinellas Planning Council recommends adopting the proposed change as a means to

encourage additional high wage jobs.

At the request of Commissioner Eggers, Mr. Crawford provided background information and indicated that the proposed amendment would increase Transferable Development Rights from 25 percent to 30 percent for the receiving parcel; and that Temporary Lodging Intensity Standards would allow an additional 10 percent floor area ratio for small parcels.

Attorney Bennett related that no action is needed at this time; and that the second hearing is scheduled for May 24.

## COUNTY ADMINISTRATOR REPORTS

36. County Administrator reports: Community Engagement update.

Mr. Woodard provided an update regarding the Board's community activities, noting that last week's Community Conversation was a success; that approximately 80 citizens attended; that 350 people participated via social media; and that there were 1,400 simultaneous listeners to the presentation. He announced that the Board has been invited to attend a meeting of the Council of North County Neighborhoods on May 16 from 7:00 to 8:30 P.M. and a Tierra Verde Community Association meeting on June 22 from 3:00 to 5:00 P.M.; whereupon, Commissioner Morroni requested that the Commissioners arrive in Tierra Verde a half-hour early to meet and greet the residents.

Mr. Woodard related that the Board had requested that Board meetings and work sessions be held in the community to engage the public; and that the following meetings have been scheduled:

- August 16 in Gulfport from 5:00 to 6:30 P.M.
- September 20 in Tarpon Springs from 5:30 to 7:00 P.M.
- October 18 in Pinellas Park from 5:30 to 7:00 P.M.

Chairman Justice thanked staff for the extra work to coordinate the outreach; whereupon, in response to queries by Commissioner Long, Mr. Woodard indicated that it is appropriate for the members, as invited guests, to arrive at the community association meetings a half-hour early to meet with residents; that it is up to the Board's discretion whether to network prior to the community work sessions; and that he will brief the members with respect to community issues. He related that there are no specific items slated for the work sessions at this time; and that more dialogue regarding the meeting format will take place as the dates near; whereupon, Commissioner Morroni

noted the importance of getting the word out so that the public is aware of the different locations.

## COUNTY COMMISSION

### 37. Appointment of alternate member to the Historic Preservation Board.

Estelle Loewenstein appointed to serve a three-year term.

Chairman Justice introduced candidate Neil McMullen, noting that Estelle Loewenstein was introduced earlier in the meeting. Commissioner Gerard

Agreed with comments by Commissioner Long, noting that a different approach is needed to find a solution to transportation issues.

Commented on last week's Community Conversation and invited the public to provide input at upcoming meetings in various communities.

Commissioner Eggers

Encouraged Board leadership and increased public participation with regard to transportation issues, noting the many upcoming meeting opportunities.

Thanked Mr. Woodard, Assistant County Administrator John Bennett, and staff for assistance in reaching out and engaging in a flood discussion with the Tarpon Woods community.

Encouraged public discussion regarding the Palm Harbor Historic Master Plan Update and the changes to be implemented early next year.

Congratulated today's EMS winners, thanked the Emergency Medical community for its hard work, and expressed gratitude to the EMS personnel who responded to his emergency.

Noted the importance of John Bennett's water safety plan for Pinellas County.

Commissioner Seel

Cheered the stellar Emergency Medical system for saving lives.

Discussed the progress being made by the Tampa Bay Transportation Management Area Leadership Group, comprised of representatives from the Pasco, Pinellas, and Hillsborough County Metropolitan Planning Organizations.

Related that the Metropolitan Planning Organization has merged with the Pinellas Planning Council and is now known as Forward Pinellas; and that three County Commissioners serve on its board.

Briefly discussed Penny for Pinellas transportation accomplishments, including the Gateway Express and ITS/ATMS projects, and noted that there are numerous public requests for an alternate east-west route.

Attended the Intercultural Institute for Alliances' luncheon last week with Commissioner Gerard and Mr. Woodard.


