Department Purpose

The Supervisor of Elections (Supervisor) conducts Federal, State, County, and Municipal elections. The Supervisor registers voters and maintains accurate voter registration records using the Florida Voter Registration System (FVRS), in accordance with federal and state law. The Supervisor recruits, trains, and assigns poll workers, locates and contracts with polling places, and surveys polling places to make improvements to comply with Americans with Disabilities Act (ADA) accessibility requirements. The Supervisor conducts voter registration and education for college, high school, middle and elementary students. The Supervisor provides sample ballots to voters as required by law. The Supervisor complies with bilingual requirements of Section 203 of the Voting Rights Act (VRA).

The Supervisor of Elections program includes the following responsibilities:

Elections:

- Conduct Federal, State, County, and Municipal elections
- Qualify candidates for County, Special District, and Precinct Committeemen and Committeewomen elections
- Recruit, train, and assign poll workers
- · Locate and contract with polling places
- · Survey polling places to comply with ADA accessibility requirements
- Maintain voting equipment and supplies
- Comply with bilingual requirements of Section 203 of the Voting Rights Act

Voter Registration:

- Register voters and maintain accurate voter registration records in accordance with the National Voter Registration Act (NVRA), Florida law, and the Florida Voter Registration System (FVRS)
- Comply with bilingual requirements of Section 203 of the Voting Rights Act

Voter Education:

- Voter education, registration, and outreach for all citizens (including senior citizens, minority community groups, language community groups, persons with disabilities, and students of all grade levels)
- Provide sample ballots to voters as required by Florida law
- Comply with bilingual requirements of Section 203 of the Voting Rights Act

Budget Drivers

- The FY26 Budget for the Supervisor of Elections decreases \$463,640 (3.6%) to \$12.5M.
- Personnel Services increases \$457,140 (7.3%) to \$6.8M. This is due to two FTE that were omitted from the FY25 budget, which has been corrected, as well as Florida Retirement System (FRS) actuarial retirement increases
- The Department's FTE remains flat at 52.0.
- Operating Expenses increases \$848,130 (17.6%) to \$5.7M. This is primarily for election cycle adjustments, which increased \$751,954 over FY25.


