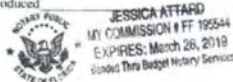



You can use this for the new ad making any adjustments as necessary. The opening paragraph was expanded across the width of the ad for consistency.

April 21 is fine for the publication date as long as it meets your requirements. The 2015 ad was a display ad in the B Section of the paper.

I think that would put our advertisement date at 4/21 if I count correctly.

I'm not sure on the type of publication this should be, do you know what determines whether it should be a display ad or a legal notice? I believe that in May of 2015 when we had a public hearing for the rate increases that it was published as a legal notice.
