PS: The following is a list of my efforts to date, to stop the thievery and recover the stolen money.

May 21, 2024, I appeared before the County Commission meeting. Using the 3-minute citizen comment opportunity, I informed the Commission of the theft and asked for their help. I left each Commissioner my contact information. Nobody has contacted me.

June 7, 2024 I emailed County Administrator Burton's office. I asked for an appointment to discuss recovering money stolen from the people of Pinellas County.

June 10, 2024 I received an email from Burton's assistant, Della Klug, inviting me to become

a county vendor, via her attached hyperlink.

June 11,2024 I made my second appearance before the County Commission. Using the 3-minute citizen comment opportunity, I told them of a vast amount of money being stolen from the people of Pinellas County. I gave each member my contact information. Again, nobody has contacted me.

July 8,2024 I emailed Administrator Burton to clarify my position, and I sent a copy of my email to each County Commissioner and The County Attorney. Again, nobody has contacted me.

July 16,2024 I made my third appearance before the County Commission. Using the 3-minute citizen comment opportunity, I again told the Commission of the stolen money. I gave each member my contact information. Again, nobody has contacted me.

July 17,2024 I called Commissioner Latvala. I spoke to Tyler and asked for an appointment with Commissioner Latvala to discuss recovering the millions of dollars stolen from the people of Pinellas County. Tyler said as soon as the Commissioner comes to work, he would tell the Commissioner of my call. Commissioner Latvala has not contacted me.

July 20,2024 Using Della Klug's hyperlink I registered as a vender, "vending information".

July 22,2024, I called William Harvey in the contracting department. The phone was answered by Bill Lawrence, I told him I wanted to sell, under contract, vital and comprehensive whistle-blower information. Lawrence said he could not initiate a contract. He said he requires a request from a County Government entity to buy anything. Lawrence recommended I ask one of the departments that has been stolen from to initiate the purchase of my information, since I am a vender.

July 22,2024 I called County Clerk Burke's office. I spoke to Pamela. Pamela made an appointment for me to meet with Clerk Burke at 1:00 PM July 23,2024

July 23,2024. I met with Clerk Burke and Inspector General Dondero. We discussed Florida's need for a whistle-blower law that protects Government. We discussed the stolen money and how we could recover it. Clerk Burke said he needed 2 weeks (August 6th, 2024) to study the problem.

Aug. 8,2024 I met with Clerk Burke at his office. Clerk Burke said the job of recovering the money is Inspector General Dondero's. I have not heard from Inspector Dondero.

Aug.13,2024 I made my fourth appearance before the Pinellas County Commission.

Sept.4,2024 I wrote Governor DeSantis. Nothing.

Sept.19,2024 I appeared for the 5th time before the Pinellas County commission again telling them of the vast amount of money being stolen from the people of Pinellas County, I gave each commissioner my contact information the Commissioners sat on their hands.

Oct.29, 2024 I made my 6th appearance before the Pinellas County Commission. Nothing.

Nov. 12, 2024 I visited the Commission offices on the fifth floor. I left a note for Commissioner Latvala. Nothing.

Nov of 2024 I called the commissioner in whose district I live and vote, 6 times asking for a brief appointment. Commissioner Latvala has ignored me, his constituent, 6 times.

Nov.14, 2024 I wrote and mailed this letter to Jewel White our County Attorney.
