First Amendment to the Agreement with Halff Associates, Inc. for the professional engineering design services for the Manufactured Home Communities Wastewater Collection Systems improvement project funded by the Restore Act.

Recommended Action:

Approval and execution by the Purchasing Director of the First Amendment to the agreement with Halff Associates, Inc.

- First Amendment to the Agreement for a time only extension from March 17, 2024, to March 31, 2027.
- There is no fiscal impact associated with this amendment.
- This contract was awarded by the Board of County Commissioners September 8, 2022, in the amount of \$2,049,452.75 for 475 days.

Contract No. 22-0056-NC; extension for one thousand one hundred nine (1,109) consecutive calendar days through March 31, 2027.

FIRST AMENDMENT

This Amendment made and entered into this <u>26th</u> day of <u>June</u>, 2024, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Halff Associates, Inc., Tampa, FL hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on September 8, 2022, pursuant to Pinellas County Contract No. 22-0056-NC (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Professional Engineering Services for the COUNTY to develop new wastewater collection systems located in unincorporated Pinellas County; and

WHEREAS, Section twenty-three (23) of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an extension of an additional one thousand one hundred nine (1,109) consecutive calendar days until March 31, 2027, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

1. The Term is hereby extended for an additional one thousand one hundred nine (1,109) consecutive calendar days period until March 31, 2027.

2. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.
