

AGREEMENT BETWEEN

This Agreement between the Florida Department of Health, and Pinellas County Florida, a subdivision of the State of Florida, is a condition precedent to issuance of Purchase Order Number **PSR69**, a separate legal, binding agreement which provides for certain PICH (as defined below) federal grant funds to be issued to the County. This Agreement shall only become effective upon (1) execution of this Agreement by both parties, and (2) formal execution of PSR69. This Agreement shall expire on September 30, 2016. The criteria set forth herein must be met by September 30, 2016, unless this Agreement is duly terminated at an earlier date by either party in accordance with Section H below.

Services to be Provided

1. Definition of Terms.
 - a. Agreement Terms
 - 1) Health Department - The Florida Department of Health (Department) is an executive branch state agency which provides public health services in Pinellas County. Its county health department is both state and county funded to provide services in Pinellas County.
 - 2) Provider - The Pinellas County Extension – The Extension is a cooperative partnership between the Pinellas County Government and the University of Florida in Gainesville.
 - 3) Partnerships to Improve Community Health (PICH) is a three-year grant funded by the U.S. Department of Health and Human Services Centers for Disease Control (CDC) to support implementation of voluntary policy and systems changes to encourage healthy choices in physical activity and nutrition locally, state and nationwide.
 - 4) Early Learning Coalition of Pinellas County (ELC) is a not for profit planning and funding agency focused on early care and education.
 - b. Program Specific Terms.

HEPA Standards - Heathy Eating Physical Activity (HEPA) – Best practice standards for healthy eating and physical activity in out of school time programs. The program addresses snack content and quality, staff training, curriculum, social support, program support and environmental support.

Healthy Habits for Life Childcare Resource Kit – A comprehensive tool kit to integrate nutrition and physical activity into out of school time programs.

2. General Description.
 - a. General Statement. The Provider will provide a person to coordinate with the Early Learning Coalition and the Pinellas County Childcare Licensing Board to improve opportunities for healthy food and beverage access and improved access to safe, low cost physical activity opportunities.
 - b. Authority. Grant Title: Partnerships to Improve Community Health, CFDA# 93.331, Cooperative Agreement 1U58DP005597, F.S. 381.0054
 - c. Scope of Service. The Department received and administers a federal grant (PICH). The Department will work with public entities including the Provider to achieve the overall goal of reducing the prevalence of obesity and chronic diseases in Pinellas County. The goal through the Provider's purchase order is to implement a training process for childcare centers on the new HEPA standards and to provide technical assistance to help centers incorporate the standards into their daily schedules.

B. Manner of Service Provision

1. Provider Responsibilities

Provider Unique Activities:

The Provider agrees to comply with agreement specifications listed in C. and D.
2. Health Department Responsibilities
 - a. The Department will provide technical support for reports and other information required by CDC.
 - b. The Department has final authority over approving the quality and acceptability of service deliverables.

C. Deliverables

1. Designate a Training Specialist for the PICH Program
2. Provide in-service trainings on HEPA standards through ELC Professional Development Trainings.
3. Provide trainings and technical assistance in child care centers to implement HEPA standards.
4. Train child care professionals on Healthy Habits for Life curriculum.
5. Provide technical assistance to child care centers to implement HEPA standards and best practices for obesity prevention.
6. Work with Pinellas County Childcare Licensing Board and PICH staff to add HEPA training as part of the mandatory trainings available to child care providers.
7. Attend all scheduled PICH partner meetings.

D. Minimum Performance Levels

1. Training Specialist is in place by October 30, 2015.

2. Provide a minimum of two Professional Development trainings for childcare providers by August 30, 2016.
3. Provide technical assistance to a minimum of twenty two child care centers to implement HEPA standards.
4. A minimum of sixty six child care professionals will be trained by August 30, 2016.
5. A minimum of four child care centers will implement HEPA standards by August 30, 2016.
6. HEPA training will be included as part of child care licensing yearly trainings by August 30, 2016.
7. Attend or send delegate to all scheduled monthly PICH partner meetings.

Financial Consequences: If monthly deliverables are not met a 5% reduction in payment will be applied to that month's invoice.

E. Method of Payment

1. Payment.

This is a fixed price (fixed fee) agreement. The Department will pay the Provider for completion of deliverables in accordance with the terms and conditions of this agreement \$2,208 per month for a total dollar amount not to exceed \$26,496 subject to the availability of funds.
2. Invoice Requirement.
 - a. The Provider shall request payment on a monthly basis through submission of a properly completed invoice within thirty (30) days following the end of the month for which payment is being requested. The invoice must be submitted with supporting documentation and a progress report of Section D.
 - b. Any portion of the deliverable payments received that are not supported by documentation will be returned to the Health Department. Deliverables that have not been received or have been received and determined to be unacceptable will not be paid.

F. CDC Funding Restrictions

1. Funding Restrictions include:
 - Provider may not use funds for research.
 - Provider may not use funds for clinical care.
 - Provider may use funds only for reasonable program purposes, including personnel, travel, supplies, and services.
 - Provider may not use funds to purchase furniture or equipment.
2. No funds may be used for:

- Publicity or propaganda purposes, for the preparation, distribution, or use of any material designed to support or defeat the enactment of legislation before any legislative body
- The salary or expenses of any grant or contract recipient, or agent acting for such recipient, related to any activity designed to influence the enactment of legislation, appropriations, regulation, administrative action, or Executive order proposed or pending before any legislative body

G. Special Provisions

a. **Monitoring.**

1) The Provider agrees to maintain fiscal records documenting all expenditures that are applicable to this contract, participant records, and curriculum materials used in the provision of services. Records will be available for review by the Department.

2) **Monitoring and Evaluation Methodology.**

By execution of this agreement the Provider hereby acknowledges and agrees that its performance under the agreement must meet the standards set forth above and will be bound by the conditions set forth below. If the Provider fails to meet these standards, the department, at its exclusive option, may allow up to one (1) month for the Provider to achieve compliance with the standards. If the Department affords the Provider an opportunity to achieve compliance and the Provider fails to achieve compliance within the specified time frame, the Department will terminate the agreement in the absence of any extenuating or mitigating circumstances.

The determination of the extenuating or mitigating circumstances is the exclusive determination of the Department.

- b. **No Lobbying.** State funds cannot be used to lobby the Executive or Legislative branches of the Federal Government in connection with the health department
- c. **Discriminatory Vendor List.** Provider acknowledges it is informed of provisions of 287.134 (2)(a), F.S., and represents to the health department that those provisions do not prohibit the health department from contracting with the Provider or any subcontractors hereunder.
- d. **E-Verify system.** Provider agrees to utilize the U.S. Department of Homeland Security's E-Verify system, <https://e-verify.uscis.gov/emp>, to verify the employment eligibility of all new employees hired during the contract term by the provider.
- e. **Public Access.** Allow public access to all documents, papers, letters or other materials subject to the provisions of Chapter 119, FS, made or received by the Provider in conjunction with this contract. It is expressly understood that the Provider's refusal to comply with this provision shall constitute an immediate breach of contract.
- f. **Return of Funds.** To return to the department any overpayments due to unearned funds or funds disallowed and any interest attributable to such funds pursuant to the terms of this agreement that were disbursed to the Provider by the Department.

H. Termination

1. Termination at Will

This contract may be terminated by either party upon no less than thirty (30) *calendar days'* notice in writing to the other party, without cause, unless a lesser time is mutually agreed upon in writing by both parties. Said notice shall be delivered by certified mail, return receipt requested, or in person with proof of delivery.

2. Termination Because of Lack of Funds

In the event funds to finance this contract become unavailable, the Department may terminate the contract upon no less than *twenty-four (24) hours'* notice in writing to the provider. Said notice shall be delivered by certified mail, return receipt requested, or in person with proof of delivery. The Department shall be the final authority as to the availability and adequacy of funds. In the event of termination of this contract, the provider will be compensated for any work satisfactorily completed prior to notification of termination.

3. Termination for Breach

This contract may be terminated for the provider's non-performance upon no less than *twenty-four (24) hours'* notice in writing to the provider. If applicable, the Department may employ the default provisions in Chapter 60A-1.006(3), F.A.C. Waiver of breach of any provisions of this contract shall not be deemed to be a waiver of any other breach and shall not be construed to be a modification of the terms of this contract. The provisions herein do not limit the Department's right to remedies at law or in equity.

FINANCIAL AND COMPLIANCE AUDIT

The administration of resources awarded by the Department of Health to the provider may be subject to audits and/or monitoring by the Department of Health, as described in this section.

MONITORING

In addition to reviews of audits conducted in accordance with 2 CFR Part §200.500, formerly OMB A-133 and Section 215.97, F.S., monitoring procedures may include, but not be limited to, on-site visits by Department of Health staff, limited scope audits, and/or other procedures. By entering into this agreement, the provider agrees to comply and cooperate with any monitoring procedures/processes deemed appropriate by the Department of Health. In the event the Department of Health determines that a limited scope audit of the provider is appropriate, the provider agrees to comply with any additional instructions provided by the Department of Health to the provider regarding such audit. The provider further agrees to comply and cooperate with any inspections, reviews, investigations, or audits deemed necessary by the Chief Financial Officer (CFO) or Auditor General.

AUDITS

PART I: FEDERALLY FUNDED

This part is applicable if the provider is a State or local government or a non-profit organization as defined in 2 CFR Part §200.500.

1. In the event that the provider expends \$750,000 or more in Federal awards during its fiscal year, the provider must have a single or program-specific audit conducted in accordance with the provisions of 2 CFR Part §200.501. EXHIBIT 1 to this agreement indicates Federal resources awarded through the Department of Health by this agreement. In determining the Federal awards expended in its fiscal year, the provider shall consider all sources of Federal awards, including Federal resources received from the Department of Health. The determination of amounts of Federal awards expended should be in accordance with the guidelines established by 2 CFR Part §200.502-§503. An audit of the provider conducted by the Auditor General in accordance with the provisions of 2 CFR Part 200.500 will meet the requirements of this part.
2. In connection with the audit requirements addressed in Part I, paragraph 1, the provider shall fulfill the requirements relative to auditee responsibilities as provided in 2 CFR Part §200.508 - §200.512.
3. If the provider expends less than \$750,000 in Federal awards in its fiscal year, an audit conducted in accordance with the provisions of 2 CFR Part §200.501(d) is not required. In the event that the provider expends less than \$750,000 in Federal awards in its fiscal year and elects to have an audit conducted in accordance with the provisions of 2 CFR Part §200.506, the cost of the audit must be paid from non-Federal resources (i.e., the cost of such audit must be paid from provider resources obtained from other than Federal entities.)
4. An audit conducted in accordance with this part shall cover the entire organization for the organization's fiscal year. Compliance findings related to agreements with the Department of Health shall be based on the agreement's requirements, including any rules, regulations, or statutes referenced in the agreement. The financial statements shall disclose whether or not the matching requirement was met for each applicable agreement. All questioned costs and liabilities due to the Department of Health shall be fully disclosed in the audit report with reference to the Department of Health agreement involved. If not otherwise disclosed as required by 2 CFR Part §200.510, the schedule of expenditures of Federal awards shall identify expenditures by funding source and contract number for each agreement with the Department of Health in effect during the audit period. Financial reporting packages required under this part must be submitted within the earlier of 30 days after receipt of the audit report or 9 months after the end of the provider's fiscal year end.

PART II: STATE FUNDED

This part is applicable if the provider is a nonstate entity as defined by Section 215.97(2), Florida Statutes.

1. In the event that the provider expends a total amount of state financial assistance equal to or in excess of \$500,000 in any fiscal year of such provider (for fiscal years ending September 30, 2004 or thereafter), the provider must have a State single or project-specific audit for such fiscal year in accordance with Section 215.97, Florida Statutes; applicable rules of the Department of Financial Services; Chapters 10.550 (local governmental entities) or 10.650 (nonprofit and for-profit organizations), and Rules of the Auditor General. EXHIBIT I to this agreement indicates state financial assistance awarded through the Department of Health by this agreement. In determining the state financial assistance expended in its fiscal year, the provider shall consider all sources of state financial assistance, including state financial assistance received from the Department of Health, other state agencies, and other nonstate entities. State financial assistance does not include Federal direct or pass-through awards and resources received by a nonstate entity for Federal program matching requirements.
2. In connection with the audit requirements addressed in Part II, paragraph 1, the provider shall ensure that the audit complies with the requirements of Section 215.97(8), Florida Statutes. This includes submission of a financial reporting package as defined by Section 215.97(2), Florida Statutes, and Chapter 10.550 (local governmental entities) or 10.650 (nonprofit and for-profit organizations), Rules of the Auditor General.
3. If the provider expends less than \$500,000 in state financial assistance in its fiscal year (for fiscal years ending September 30, 2004 or thereafter), an audit conducted in accordance with the provisions of Section 215.97, Florida Statutes, is not required. In the event that the provider expends less than \$500,000 in state financial assistance in its fiscal year and elects to have an audit conducted in accordance with the provisions of Section 215.97, Florida Statutes, the cost of the audit must be paid from the nonstate entity's resources (i.e., the cost of such an audit must be paid from the provider resources obtained from other than State entities).
4. An audit conducted in accordance with this part shall cover the entire organization for the organization's fiscal year. Compliance findings related to agreements with the Department of Health shall be based on the agreement's requirements, including any applicable rules, regulations, or statutes. The financial statements shall disclose whether or not the matching requirement was met for each applicable agreement. All questioned costs and liabilities due to the Department of Health shall be fully disclosed in the audit report with reference to the Department of Health agreement involved. If not otherwise disclosed as required by Rule 69I-5.003, Fla. Admin. Code, the schedule of expenditures of state financial assistance shall identify expenditures by agreement number for each agreement with the Department of Health in effect during the audit period. Financial reporting packages required under this part must be submitted within 45 days after delivery of the audit report, but no later than 9 months after the provider's fiscal year end for local governmental entities. Non-profit or for-profit organizations are required to be submitted within 45 days after delivery of the audit report, but no later than 9 months after the provider's fiscal year end. Notwithstanding the applicability of this portion, the Department of Health retains all right and obligation to monitor and oversee the performance of this agreement as outlined throughout this document and pursuant to law.

EXHIBIT 3**INSTRUCTIONS FOR ELECTRONIC SUBMISSION
OF SINGLE AUDIT REPORTS**

Single Audit Reporting Packages (“SARP”) must be submitted to the Department in an electronic format. This change will eliminate the need to submit multiple copies of the reporting package to the Contract Managers and various sections within the Department and will result in efficiencies and cost savings to the Provider and the Department. Upon receipt, the SARP’s will be posted to a secure server and accessible to Department staff.

The electronic copy of the SARP should:

- Be in a Portable Document Format (PDF).
- Include the appropriate letterhead and signatures in the reports and management letters.
 - Be a single document. However, if the financial audit is issued separately from the Single Audit reports, the financial audit reporting package may be submitted as a single document and the Single Audit reports may be submitted as a single document. Documents which exceed 8 megabytes (MB) may be stored on a CD and mailed to: **Bureau of Finance & Accounting, Attention: Single Audit Review, 4052 Bald Cypress Way, Bin B01 (HFA), Tallahassee, FL 32399-1729.**
- Be an exact copy of the final, signed SARP provided by the Independent Audit firm.
- Not have security settings applied to the electronic file.
- Be named using the following convention: [fiscal year] [name of the audited entity exactly as stated within the audit report].pdf. For example, if the SARP is for the 2009-10 fiscal year for the City of Gainesville, the document should be entitled 2010 City of Gainesville.pdf.
- Be accompanied by the attached “Single Audit Data Collection Form.” This document is necessary to ensure that communications related to SARP issues are directed to the appropriate individual(s) and that compliance with Single Audit requirements is properly captured.
