	I am the owner of a preschool and childcare center in Pinellas County (Tarpon Springs). We have been hoping and rallying for some help in expanding our capacities within our program to serve the families who need us. The Governor announced lifting restrictions yesterday and we truly had hoped that would apply to us as well. The current understanding is that it will not include us, and this has me worried and threatens our livelihood immensely. Let me take a moment to explain further.							
	The capacity/group sizes of 10 people (including staff) has obviously been challenging for us as parents need care, and we want to provide. For my small-ish center specifically - we were caring for more than 70 kids before and can only help 18 now, (and 5 of those 18 belong to staff children - so essentially only 13 community children). I can understand the precautions and parents have been understanding and waiting for the time when the children can return. So, so far - it's not the best scenario - but we're making it work. I have seen some parents take to social media pleading for neighbors or strangers to care for their children, which has me concernedbut this new order update may help them.							
	The concern for US as childcare providers is that if "camps" are allowed to take the children, and our centers are not - parents will have no choice but to sign children up for these camps in order to return to work. This will directly take our business and money from our center's pocket for weeks (months) to come. Our center is more than 1/2 school age care, meaning that my almost 40 children will be enrolling into sports programs or whatever type camps are allowed to function without the restrictions that we have. So, if we do end up getting capacity back later, our clients will be enrolled elsewhere already, causing us to not be able to get back up and running once things are better.							
	I have been content in all of this, knowing that we will be ok in a while and once we re-open, our families are waiting and will return-but this change of order has me more concerned as my customers may potentially be taken away as they have no other option. We must expand childcare center capacities AS we lift restrictions for camps in order to keep things fair and not damage the businesses that are critical for children year round!!!
