**PRINCIPAL PROJECTS**

**1. PROJECTS OF HISTORIC SIGNIFICANCE**

**Bowery Savings Bank Historic Restoration  
New York, New York**

Designed by McKim, Meade & White and completed in 1894 the facility was completely restored from top to bottom while remaining open for business. The work included restoration of the original lay light, cleaning of marble and bronze decorative detailing and the cleaning, repainting, and relighting of the vaulted ceiling. The work was performed based on drawings and renderings discovered by the restoration team in the bank's archives.

**New York Athletic Club  
New York, New York**

Designed by York & Sawyer, the 22-story 'City House' opened in 1929. Facilities include 150 hotel rooms, gym, and pool; tap room, restaurant, squash/handball courts and meeting rooms. Serving as the Architectural Advisor to the Board of Governors I was responsible for master planning and phasing of the renovation. Work included facade and parapet restoration, a new women's locker room, upgrading telecommunications and data service, modernization of the bath/cabana and implementation of a club-wide ADA compliance program.

**Student Center Expansion Project, University of North Carolina - Wilmington  
Wilmington, North Carolina**

This \$24.0 million project, scheduled to begin construction in the spring of 2003, is composed of 4 phases. The design challenge was to blend the new building and additions to two existing buildings with the campus-wide Georgian architectural vocabulary. I functioned as project manager for all phases beginning with extensive relocation of site utilities and construction of a Central Energy Plant and coordinating the activities of the design architect (Burt Hill Kosar Rittleman in Philadelphia) for a two-story 60,000 SF Student Activities Center (including a 400 seat THX Theater and the University Bookstore). I was also the project manager and restoration/renovation lead architect for the existing University Union, and conversion of the Burney Center into a 900-seat ballroom-conference center. The renovation scope encompassed major additions to the façade of the University Union and a complete reconfiguration of the Burney exterior and interior. Design reviews had to meet intense scrutiny and oversight throughout the university's leadership hierarchy beginning with Facilities Planning & Design and ending in the Chancellor's office.

**Cameron Indoor Stadium Stair Tower/AC Addition, Duke University  
Durham, North Carolina**

Home of the Blue Devils 2001 NCAA Basketball Champions the stadium lacked air-conditioning, and emergency egress was a serious concern to university officials. The stair tower addition was the subject of intense design study because of the need to blend in with and respect the traditional architecture of the west campus. The air-conditioning project required careful phasing to respect the demands of the basketball schedule and summer volleyball camps.

**2. NEW URBANISM/TRADITIONAL NEIGHBORHOOD DESIGN/TOWN PLANNING**

***Hometown Aurora & Home Town Farnsworth, Aurora, Illinois***

***Blanco River Village, San Marcos, Texas***

***Hometown LaGrange, LaGrange, Georgia***

As Director of Design for Bigelow Development (aka Bigelow Homes) I worked closely with Perry Bigelow in planning these communities and designing single and multi-family residences. Guided by the ideas set forth by Christopher Alexander in his book "A Pattern Language" and others, our work focused on creating traditional neighborhoods with kid safe streets, and a variety of housing types available at affordable prices. Although no two developments are alike our communities typically covered 200 +/- acres, 1500 homes, multiple product lines, automobile free living courts, multiple private parks, a public park, and a mixed-use town center with lofts above retail and live/work buildings.

***The Promenade***

***Sugar Grove, Illinois***

I directed the design team for a 957acre community based on the "Transect", the primary organizing principle of New Urbanism and Traditional Neighborhood Design. The community of 2100 residences included civic, retail, and commercial uses, a golf course, public & private parks, and recreational uses. The plan featured the PROMENADE TOWN CENTER - with 750k SF of retail & commercial offices, the Village Hall and Village Library, urban lofts & row homes, a community center, farmer's market, and structured parking. Wrote & published a manual of development standards for this TND community that defined Architectural Design Guidelines, Lot Development Standards, and Minimum Architectural Requirements.

***Oanat Kosar New Town  
Teheran, Iran***

Winner of a citation from Progressive Architecture Magazine this low-rise housing development is organized around a hierarchy of spaces. The mix of dwelling units is based on an average population of 4.5 people. Fifty units are a "neighborhood," a street where residents know each other from daily life. One hundred units are planned around a "commons;" four commons form a "cluster" of 1600-2500 people with shared playgrounds and primary schools. Four clusters form an urban center of 8000 people plus or minus which can support a shopping street with residential above retail. Three such centers become a town of 22,000 to 27,000 people.

**3. EDUCATION:**

***Student Center Expansion, University of North Carolina - Wilmington  
Wilmington, North Carolina***

This \$24.0 million project, scheduled to begin construction in the fall of 2003, is composed of four phases beginning with extensive relocation of site utilities and construction of a Central Energy Plant. Subsequent phases feature construction of a two-story 60,000 SF Student Activities Center (including a 400 seat THX Theater and the University Bookstore), renovation of the existing University Union (including a complete redesign of the Hawk's Nest Dining facility), and the conversion of the Burney Student Support Center into a 900-seat ballroom and conference center. The design theme blends with the campus-wide Georgian architectural vocabulary, and construction is phased in a manner that minimizes lost time in the activity and income producing spaces on this vibrant, growing campus.

***Guilford Technical Community College, East Campus Master Plan & Technical Education Center Building, Greensboro, North Carolina***

In the fall of 2001 GTCC purchased a 42-acre tract of raw land which will become the East Campus. The master plan for this five-building site includes parking for 3000+ cars. The project involved extensive review and approval by the Army Corps of Engineers, North Carolina Department of Water Quality, and the City of Greensboro Technical Review Committee. The Technical Education Center, home of the Industrial, Construction and Engineering Technology (ICET) programs is a three-story, 105,000 SF facilities featuring a central daylight atrium. Located at the southeast corner of the site The TechEd Center is the signature building on the campus facing the intersection of East Wendover Avenue and Penry Road. The building design embodies numerous principles of sustainable design.

***Williams Cafeteria, Addition & Modernization, North Carolina A&T State University  
Greensboro, North Carolina***

This project began with a condition evaluation of this 25-year-old facility, concluding that modernization and expansion to double seating capacity was indeed feasible. Food service is redesigned as a scramble system featuring hot entrees, soups & salad, a "Euro" Grill, and a variety of other stations. The facility includes a Chancellor's Dining Room and Food Court on the ground level. The kitchen remained in full operation during the fifteen-month duration of this \$7.5 mil project. ***Cameron Indoor Stadium Stair Tower/AC Addition, Duke University  
Durham, North Carolina***

Home of the Blue Devils 2001 NCAA Basketball Champions the stadium lacked air-conditioning and emergency egress was a sincere concern to university officials given the success of the basketball program. The air-conditioning required careful phasing to respect the demands of the basketball schedule and summer volleyball camps. The stair tower itself, the subject of intense design study, reflects the traditional architecture of the west campus. Cameron.

**4. Public Sector:**

***North Carolina State Fair Multi-Purpose Events & Exhibit Hall  
Raleigh, North Carolina***

The building features a sixty-thousand square foot column free exhibit hall achieved by an architectural truss spanning two hundred ten feet with a vertical clearance of thirty feet from floor to underside of structure.
