Do not allow healthy trees to be removed without a permit or reduce the fees to remove healthy trees. We already have a state law that allows diseased trees and trees that pose a danger to be removed without a permit. Proposed changes would weaken meaningful tree protection standards. Significantly cuts Tree Bank Fund contributions (projected ~60% reduction), undermining the County's ability to replant trees, restore canopy, and invest in underserved neighborhoods most impacted by heat and flooding. Allows payment in lieu of replanting to replace on-site mitigation, which often leads to fewer trees planted where impacts actually occur and weakens ecological and community benefits. Lowers minimum trees-per-lot requirements for residential development, accelerating canopy loss in neighborhoods and increasing urban heat island impacts. Simplifies the tree rating and mitigation methodology in ways that undervalue mature and heritage trees, which provide exponentially greater environmental and public health benefits than newly planted saplings. Shifts critical protections into a new stand-alone Tree Code without strengthening enforcement, creating risk that protections are diluted rather than enhanced. 1.20 Pinellas BOCC Agenda Moves decisions further away from public oversight, limiting opportunities for community input on tree removal that directly affects neighborhood character, safety, and quality of life. 1.20 Pinellas BOCC Agenda Contradicts local climate, sustainability, and resilience goals, as reducing canopy directly worsens heat exposure, stormwater runoff, air quality, and climate vulnerability. Misses an opportunity to strengthen—not weaken—tree protections following increasingly severe hurricanes, flooding, and extreme heat impacting Pinellas County resident
