

RESOLUTION NO. 2354

A RESOLUTION OF THE CITY OF LARGO, FLORIDA, AUTHORIZING THE ACCEPTANCE OF REAL PROPERTY CONVEYED BY PINELLAS COUNTY TO THE CITY FOR THE PURPOSE OF THE CONSTRUCTION AND OPERATION OF A FIRE STATION; AUTHORIZING THE MAYOR, CITY CLERK, AND CITY ATTORNEY TO EXECUTE ALL DOCUMENTS AND DO ALL THINGS NECESSARY TO CARRY OUT SUCH CONVEYANCE; AND PROVIDING FOR AN EFFECTIVE DATE.


WHEREAS, the City of Largo provides firefighting services and other related emergency services to the residents of the City and of unincorporated areas of the County; and

WHEREAS, Pinellas County has offered to convey certain real property owned by the County in the unincorporated area to the City for the purpose of constructing a fire station.

NOW, THEREFORE, BE IT RESOLVED BY THE LARGO CITY COMMISSION:

- Section 1: That the above recitals are true and correct and incorporated into this resolution.
- Section 2: That the City Commission hereby approves the acceptance of the conveyance of the County property pursuant to the County deed, a copy of which is attached to this resolution, including the reverter clause.
- Section 3. That the Mayor, City Clerk, and City Attorney are authorized to execute any documents required to accomplish the conveyance of the real property from the County to the City, and to do all things necessary and proper to carry out such conveyance.
- Section 4. That all resolutions and parts of resolutions in conflict herewith are repealed to the extent of such conflict.
- Section 5. That this resolution shall take effect immediately upon its adoption.



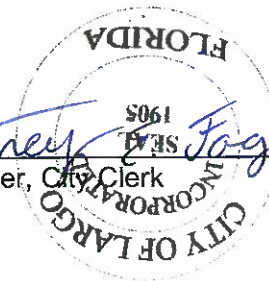

COUNTY DEED

THIS DEED, made this \_\_\_\_\_ day of \_\_\_\_\_, 2023, by PINELLAS COUNTY, a political subdivision of the State of Florida, whose address is 315 Court Street, Clearwater, Florida 33756, party of the first part (“Grantor”), to CITY OF LARGO, whose address is PO Box 296, Largo, FL, 33779, party of the second part (“Grantee”).

WITNESSETH

That the said party of the first part, for and in consideration of the sum of One Dollar (\$1.00) to it in hand paid by the party of the second party, receipt whereof is hereby acknowledged, has granted, bargained, and sold to the party of the second part, its heirs and assigns forever, subject to the special conditions described herein, the following described land lying and being in Pinellas County, Florida:

*Lands described in Exhibit “A” attached hereto  
and fully incorporated herein.*

1. This Deed and conveyance is made and accepted upon the express condition that the real property hereby conveyed shall be used solely and perpetually as a City of Largo Fire Station. This condition shall run with said real property.
2. In the event that said real property, in whole or in part, is at any time or for any reason no longer used as a City of Largo Fire Station, then title to said real property shall automatically revert to and vest in the Grantor.
3. Grantee, by accepting this Deed, hereby agrees to and acknowledges said condition and agrees that said real property shall be subject thereto.

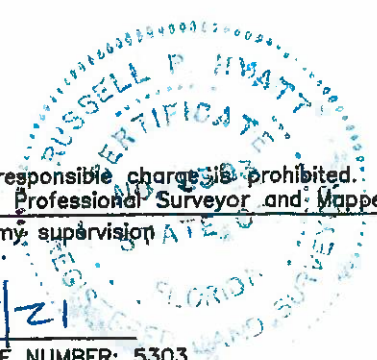

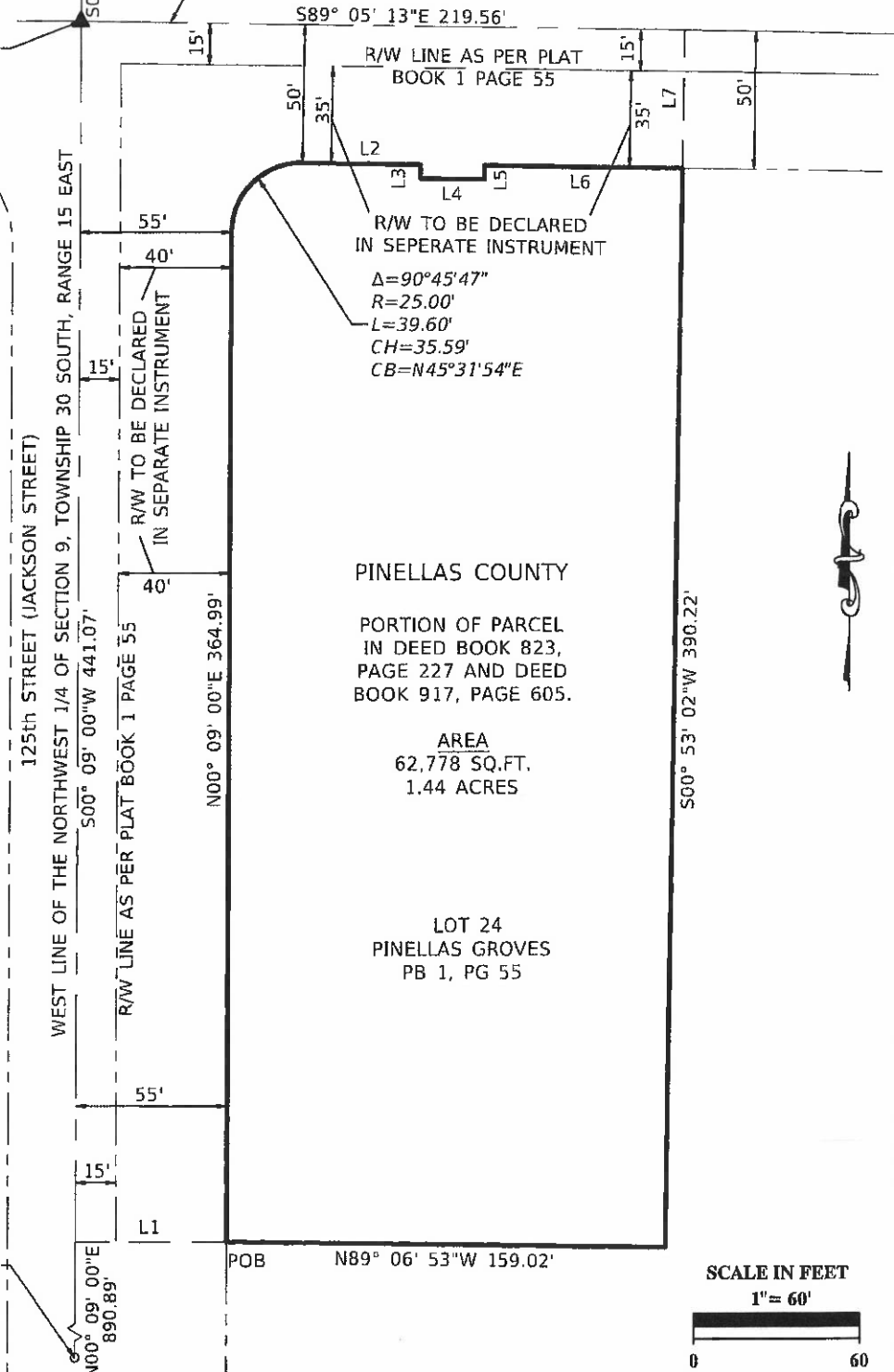
