| NOTES: The Drug Court Expansion Program is a legislative funded prison diversion drug court, which extends substance abuse treatment to a population of nonviolent felony offenders in the County who might otherwise be sentenced to prison. Participants are selected by the Sixth Judicial Circuit and must meet certain criteria, i.e., being amenable to substance abuse treatment and having an underlying offense of a nonviolent felony; however, eligibility is determined on an individual basis and a combination of factors are considered. The Office of the State Courts Administrator reimburses the County for the costs of the treatment provided by licensed substance abuse and mental healthcare service providers with whom the County contracts.
