Madam Chair, fellow Commissioners & Commissioners-elect,

I'm writing today, as a lifelong Pinellas resident, born at St. Anthony's Hospital in 1989. I've lived in Largo since I was one. My dad was from New York and my mom is from Canada. So our family was a "Yankee's" family.

However, my dad knew how important having baseball was to a community and proudly welcomed me supporting the Rays and supported them coming here, mainly, so it would be easier for him to watch the Yankee, small progress but progress nonetheless.

Unfortunately, he passed away when I was 12 in 2001 and couldn't see the Rays become the team they are today.

I remember where I was on the night of Game 142 & my first time I was able to buy playoff tickets. I love this team and have loved it since I was a kid. Below is a picture of a 7 year old me wearing a "We Built It, They Came" Devil Rays shirt at Niagara Falls with my mom followed by a picture of us from a couple years ago.



I want the Rays to stay in Pinellas county but I also expect and demand they be decent, honest and respectful partners when we are giving substantial public money to build a private sports stadium.

I'm very troubled that the Rays have resisted calls by this commission to come and address it, so we can start to envision what the future will look like.

I don't want to lose the Rays over them playing one season in Tampa but I do expect them and the City of St. Petersburg to have a solid plan on how they can get the Rays back in the Trop or some location in Pinellas before the end of the 2026 season.

I want to thank you all for your service and I apologize for the disgusting nature of the behavior some of you have been put through and that some think is appropriate to send or publicly write.

In these politically anxious times we must always send a clear message against anyone wanting to use violence or intimidation to impact the decisions of our elected officials and I know Sheriff Gualtieri, with your help, will make sure that never happens.

I think like most of you, I wish I had the perfect solution or the perfect answer. I wish the Rays would show up and talk to us, without that I would sadly urge the commission to vote again to delay the bonds.

However, if the Rays do come to Tuesday's meeting with an apology, acceptance that they have to communicate better and a realistic plan with the City of St. Petersburg to bring baseball back to Pinellas by the end of 2026, then I would urge a yes vote.

I know these decisions aren't easy. The Rays said they were here to stay, while, like others have said, now is the time to prove it. Especially when Pinellas needs every bit of non-beach bed tax revenue to make up for the damage caused by Milton and Helene to support Pinellas's tourism industry and economy.

Good Morning Commissioners:

I urge to vote 'Not No, but Not Now' on issuing bonds to pay for the new Rays stadium in St. Pete.

Pinellas County is still mired in the aftermath of 2 major disasters, and we don't yet know how the county tax base is going to recover? How much bed tax will be lost due to a slow down in tourism? How much property tax will be lost due to the 50,000+ damaged homes getting tax adjustments? We are no longer in a strong position to get the best rates on new bonds.

And even if the bonds can be floated at the best interest rates, will there be the same tax base to pay for them? And what are the opportunity costs in the future?
