A RESOLUTION APPROVING THE ISSUANCE BY THE HOUSING FINANCE AUTHORITY OF PINELLAS COUNTY OF ITS MULTIFAMILY HOUSING REVENUE BONDS (OAKHURST TRACE), SERIES 2022 IN THE AGGREGATE AMOUNT NOT TO EXCEED \$22,000,000 TO PROVIDE FUNDS TO FINANCE THE MULTIFAMILY RESIDENTIAL RENTAL HOUSING PROJECT FOR THE BENEFIT OF SP PINELLAS III LLC, A FLORIDA LIMITED LIABILITY COMPANY, OR ITS AFFILIATE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Housing Finance Authority of Pinellas County, Florida (the "Authority") has authorized the initiation of official action to issue its Multifamily Housing Revenue Bonds (Oakhurst Trace), Series 2022 (the "Bonds") on behalf of SP Pinellas III LLC, a Florida limited liability company, to provide financing for the acquisition, construction, and equipping of a residential rental facility to be known as Oakhurst Trace, to consist of approximately 220 units to be located at the west side of U.S. Highway 19N, approximately 500 feet west of the intersection of Mainlands Boulevard W and U.S. Highway 19N, Pinellas Park, Florida; and

WHEREAS, the Authority conducted a public hearing on March 22, 2022, notice of which hearing was published on March 13, 2022, in the *Tampa Bay Times* (a copy of which notice is attached hereto as Exhibit "A" and incorporated herein), for the purpose of considering the issuance of the Bonds by the Authority in the aggregate principal amount not to exceed \$22,000,000, in conformance with the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended. Said public hearing disclosed no reason why the Bonds should not be issued.
