

**FIRST AMENDMENT TO SPECTRUM ENTERPRISE SERVICE AGREEMENT  
REGARDING CONTRACT NO. 089-0339-P**

This First Amendment (“Amendment”) to the Spectrum Enterprise Service Agreement, dated January 12, 2021 is made and entered into on the date last executed below (“Effective Date”), by and between Pinellas County, a political subdivision of the State of Florida (hereinafter referred to as “County”) and Charter Communications Operating, LLC (“Contractor”), (each such party individually referred to as a “Party”, and collectively as the “Parties”). Capitalized terms used herein shall have the meanings assigned to them in the Agreement (defined below) unless otherwise defined herein.

WITNESSETH:

**WHEREAS**, the Board of County Commissioners approved the Contract Award dated January 21, 2021 (“Contract Award”) to Contractor which authorized the County to place orders with Contractor for certain telecommunications services (“Services”) for a five (5) year period (“Award Term”); and

**WHEREAS**, the County and the Contractor entered into the Spectrum Enterprise Service Agreement on January 12, 2021, referred to in the Pinellas County records as Pinellas County Contract No. 089-0339-P (hereinafter “Agreement”), through which the Contractor agreed to provide the Services to the County in connection with the Contract Award; and

**WHEREAS**, in consideration of the mutual promises contained below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County now desires to amend the Contract Award and Agreement to extend the Award Term for an additional five (5) year period and increase the not-to-exceed amount which can be expended under the Agreement, as set forth below:

NOW THEREFORE, the Parties agree that the Agreement and Contract Award are amended as follows:

1. The Award Term is hereby extended for an additional sixty (60) months from January 11, 2026, to January 11, 2031.
2. For County budget and appropriation purposes, the current total not-to-exceed amount under the Agreement of \$10,558,080.55 is revised to reflect an increase in the amount of \$5,700,000.00 for a new total not-to-exceed expenditure of \$16,258,080.55. Notwithstanding the foregoing, Contractor shall not be responsible for monitoring or reporting on these amounts.
3. Except as modified by this Amendment, all terms and conditions of the Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.

IN WITNESS WHEREOF the Parties herein have caused this Amendment to be executed by their undersigned officials, who are duly authorized to bind the Parties to the Amendment.
