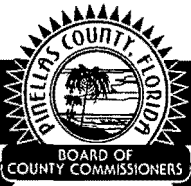

All levels of this government are in need of being corrected, both past, present and future! Pg80 of Maloney's water code reveals the hindmost objective of this government belongs to that of the Devil.

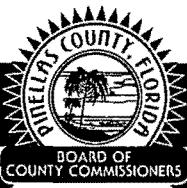
This government is officially at war with Christianity.

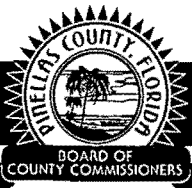
