Following is additional information, clarifications, questions and responses relative to referenced Bid (ITB):

CLARIFICATIONS:

Section B, 20, E, is replaced with the following paragraph: "The Contractor shall pay to the County, as reimbursement of costs incurred by the County, the sum of ONE HUNDRED DOLLARS (\$100.00) per man **hour** for each Saturday and Sunday on which the Contractor Works."

Section B, 20, F, is replaced with the following paragraph: "The Contractor shall pay to the County, as reimbursement of costs incurred by the County, the sum of ONE HUNDRED **FIFTY** DOLLARS (\$150.00) per man **hour** for each recognized Holiday on which the Contractor Works."

QUESTION(S)/RESPONSE(S):

1. Question: I have a question about the McKay Creek Reclaimed Water Pump Station Valve Improvements (PID No. 003207A) project. I saw that all six of the Automatic Strainers are set for demolition. I was wondering if there are intentions to replace those units. Our company is a manufacturer of Automatic Strainers and we would be happy to assist in the sizing of the strainers and providing pricing if needed. I look forward to your response.

Response: The strainers will not be replaced.

2. Question: In attachment for the specs for the project in the bid docs, the sections go from 26 30 00-8 to 40 05 20-1. We can't seem to find where Divisions 31 (Earthwork), 32 (Exterior Improvements) and 33 (Utilities) are. Would you please advise?
