This Supplemental Agreement ("Supplemental"), dated January 5, 2024 arises from the desire to supplement the State-Funded Grant Agreement ("Agreement") entered into and executed on June 08, 2023 as identified above. All provisions in the Agreement and supplements, if any, remain in effect except as expressly modified by this Supplemental.

The parties agree that the Agreement is to be amended and supplemented as follows:

This supplemental agreement adjusts project funding to reflect the current project estimate of \$2,166,582.00. State funds are increased by \$748,791.00 for a total participation of \$1,083,291.00. Local funds are reduced to the total amount of \$1,083,291.00 to reflect the required funding match. Section 6. Project Cost, and Exhibits "B" Schedule of Financial Assistance and "J" State Financial Assistance (Florida Single Audit Act), attached hereto, are modified, and superseded the Exhibits of the original agreement.

Reason for this Supplemental and supporting engineering and/or cost analysis:

Due to escalating costs and additional eligible work necessary to connect multiple intersections to fiber on SR 580, the Department is increasing state funding to 50% of the current estimate as allowed per the County Incentive Grant Program. Local funds are reduced to the required 50% match.


