

## **AGREEMENT OF CONVEYANCE, TRANSFER AND ASSIGNMENT OF ASSETS AND ASSUMPTION OF OBLIGATIONS**

This Agreement of Conveyance, Transfer and Assignment of Assets and Assumption of Obligations ("Transfer and Assumption Agreement") is made effective as of July 24, 2020, by ICTC Governing Board, an entity created by an Interlocal Agreement For Tampa Bay Advanced Manufacturing Industry Training Centers in July, 2014 and governed by such board ("Assignor"), and AmSkills, Inc., a public charity qualified under Section 501(c)(3) of the Internal Revenue Code and as a not-for-profit corporation under Florida law ("Assignee").

WHEREAS, Assignor established Assignee as a separate not-for-profit organization to apply for and receive grant donations and sponsorships to support the AmSkills Initiative, now known as AmSkills, Inc.;

WHEREAS, Assignor has designated Assignee as the official operating public charity to carry out and implement the AmSkills Initiative;

WHEREAS, Assignor seeks to terminate the Interlocal Agreement entered into by and among Pasco, Hernando and Pinellas Counties and transfer all agreements, contracts, assets and liabilities from Assignor to Assignee in order to implement, carry out and expand the AmSkills Initiative;

WHEREAS, Assignor has been engaged in, operated and supported the Am Skills Initiative which was created to engage in and support workforce development, workforce training and apprenticeships (the "Initiative" or "AmSkills Initiative"); and

WHEREAS, Assignor desires to convey, transfer and assign to Assignee, and Assignee desires to acquire from Assignor, all of the assets of Assignor relating to the operation of the Initiative, and in connection therewith, Assignee has agreed to assume all of the liabilities of Assignor relating to the Initiative, on the terms and conditions set forth herein.

NOW THEREFORE, in consideration of the mutual promises and agreements contained herein, the parties hereto, intending to be legally bound hereby, agree as follows:

### **Section 1. Assignment.**

**1.1. Assignment of Assets.** For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by Assignor, Assignor does hereby assign, grant, bargain, sell, convey, transfer and deliver to Assignee, and its successors and assigns, all of Assignor's right, title and interest in, to and under the assets, properties and Initiative, of every kind and description, wherever located, real, personal or mixed, tangible or intangible, owned, held or used in the conduct of the Initiative (the "Assets"), including, but not limited to, the assets listed on Exhibit A hereto, and identified in part by reference to Assignor's most recent balance sheet (the "Balance Sheet").

**1.2 Further Assurances.** Assignor shall from time to time after the date hereof at the request of Assignee and without further consideration execute and deliver to Assignee such additional instruments of transfer and assignment, including without limitation any bills of sale, assignments of leases, deeds, and other recordable instruments of assignment, transfer and conveyance, in addition to this Transfer and Assumption Agreement, as Assignee shall reasonably request to evidence more fully the assignment by Assignor to Assignee of the Assets.

## **Section 2. Assumption of Liabilities.**

**2.1 Assumed Liabilities.** As of the date hereof, Assignee hereby assumes and agrees to pay, perform and discharge, fully and completely, (i) all liabilities, commitments, contracts, agreements, obligations or other claims against Assignor, whether known or unknown, asserted or unasserted, accrued or unaccrued, absolute or contingent, liquidated or unliquidated, due or to become due, and whether contractual, statutory, or otherwise associated with the Initiative (the “Liabilities”), including, but not limited to, the Liabilities listed on Exhibit B, and identified in part by reference to the Balance Sheet.

**2.2 Further Assurances.** Assignee shall from time to time after the date hereof at the request of Assignor and without further consideration execute and deliver to Assignor such additional instruments of assumption in addition to this Transfer and Assumption Agreement as Assignor shall reasonably request to evidence more fully the assumption by Assignee of the Liabilities.

**Section 3. Headings.** The descriptive headings contained in this Transfer and Assumption Agreement are for convenience of reference only and shall not affect in any way the meaning or interpretation of this Transfer and Assumption Agreement.

**Section 4. Governing Law.** This Transfer and Assumption Agreement shall be governed by and construed in accordance with the laws of the State of Florida applicable to contracts made and to be performed entirely within that state, except that any conveyances of leaseholds and real property made herein shall be governed by the laws of the respective jurisdictions in which such property is located.

(d) all rights, claims and causes of action against third parties resulting from or relating to the operation of the Initiative or the Assets;

(e) all governmental licenses, permits, authorizations, consents or approvals affecting or relating to the Initiative or the Assets;

(f) all notes receivable, prepaid expenses and insurance and indemnity claims to the extent related to any of the Assets or the Initiative;

(g) all goodwill associated with the Assets and the Initiative;

(h) all Initiative records, regardless of the medium of storage, relating to the Assets and/or the Initiative, including without limitation, all schematics, drawings, promotional graphics, original art work, accounting and financial information concerning the Assets or Initiative;

(i) Assignor's right to use the name "AmSkills" or "AmSkills Initiative" and all other names used in conducting the Initiative, and all derivations thereof, in connection with Assignee's future conduct of the Initiative;

(j) all internet domain names and URLs of the Initiative, software, inventions, art works, patents, patent applications, processes, trade secrets, know-how, service marks, trade names, trademarks, trademark applications, copyrights, source and object codes, drawings, ideas, algorithms, processes, computer software programs or applications (in code and object code form), tangible or intangible proprietary information and any other intellectual property and similar items and related rights owned by or licensed to Assignor used in the Initiative, together with any goodwill associated therewith and all rights of action on account of past, present and future unauthorized use or infringement thereof; and

(k) all other privileges, rights, interests, properties and assets of whatever nature and wherever located that are owned, used or intended for use in connection with, or that are necessary to the continued conduct of, the Initiative as presently conducted or planned to be conducted.

Exhibit B

- (a) All liabilities in respect of indebtedness of Assignor related to the Initiative;
- (b) taxes, duties, levies, assessments and other such charges, including any penalties, interests and fines with respect thereto, payable by Assignor to any federal, provincial, municipal or other government, domestic or foreign, incurred in the conduct of the Initiative;
- (c) liabilities for salary, employee expenses, benefits, bonus, vacation pay, severance payments damages for wrongful dismissal, or other compensation or benefits relating to Assignor's employees employed in the conduct of the Initiative;
- (d) any liability or claim for liability (whether in contract, in tort or otherwise, and whether or not successful) related to any lawsuit or threatened lawsuit or claim (including any claim for breach or non-performance of any contract) based upon actions, omissions or events relating to the Initiative; and
- (e) any liability, ongoing duty or obligation, or any claim for liability or performance of any ongoing duty or obligation arising under any and all contracts to which Assignor is a party, or which affect the Initiative or the Assets.
