BACKGROUND:

In November 2012, the voters of Pinellas County continued their commitment to public education in Pinellas County by voting to approve a continuation of the one-half mill property tax for four years. This will end on June 30, 2017.

In order to maintain the benefits of the one-half mill property revenue, it is necessary for the voters in the county to approve a continuation of the one-half mill property tax at a duly-called election.

STRATEGIC DIRECTION; Effective & Efficient Use of Resources

ALTERNATIVES:

- 1. Approve the Resolution and present the ballot question as proposed.
- 2. Do not approve the Resolution and present the ballot question as proposed.

RECOMMENDATION:

Alternative No. 1 is recommended.

RATIONALE:

The School Board is requesting the public to approve a renewal of the tax referendum in order to continue to provide additional revenue with which the district may recruit and retain quality teachers and maintain quality educational programs in academic areas and in the areas of visual arts, performing arise, reading and technology. The ballot question to be adopted by Board resolution is as follows:

"Shall the Pinellas County School District ad valorem millage of one-half mill per year be continued beginning July 1, 2017, and ending four fiscal years later on June 30, 2021, for necessary operating expenses including funds to recruit and retain teachers; preserve reading programs and music and art classes; and provide up-to-date textbooks and technology, with oversight of these expenditures by an independent citizens financial oversight committee?"

It is estimated that continuation of the one-half mill increase in ad valorem tax will generate approximately \$34 million annually beginning fiscal year 2017-2018 for the district to use for teacher salaries and designated programs and classes.

RESOLUTION

A RESOLUTION DIRECTING THE PINELLAS COUNTY COMMISSIONERS TO PLACE A MEASURE ON THE BALLOT FOR THE NOVEMBER 8, 2016, GENERAL ELECTION FOR THE ELECTORS WITHIN THE SCHOOL DISTRICT TO VOTE ON THE APPROVAL OF THE CONTINUATION OF ONE-HALF MILL AD VALOREM TAX FOR FOUR YEARS PURSUANT TO SECTION 1011.73(2), FLORIDA STATUES (2011).

WHEREAS, Section 1011.73(2), Florida Statutes (2015), authorizes the School Board pursuant to a resolution adopted at a regular meeting to direct the County Commissioners to cail an election at which the electors within the school district may approve an ad valorem tax millage as authorized under Section 1011.71(9), Florida Statues (2015); and

WHEREAS, Section 1011.71(9), Florida Statues (2015), authorizes a school district to levy, by local referendum or in a general election, additional millage for school operational purposes up to an amount that, when combined with the nonvoted millage levied said section, does not exceed the 10 mill limit established in s. 9(b), Art. VII of the State Constitution; and

WHEREAS, the School Board has determined that it is in the best interests of the school district to submit to the voters the question of approving the continuation of the one-half mill ad valorem tax for four years for necessary operating expenses;

NOW THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF PINELLAS COUNTY, FLORIDA, IN REGULAR SESSION DULY ASSEMBLED THIS 12th DAY OF APRIL, 2016, THAT THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA, IS HEREBY DIRECTED TO CALL AN ELECTION IN CONJUNCTION WITH THE GENERAL ELECTION OF NOVEMBER 8, 2016, AT WHICH THE ELECTORS WITHIN THE SCHOOL DISTRICT MAY VOTE ON THE APPROVAL OF CONTINUATION OF THE ONE-HALF MILL AD VALOREM TAX FOR FOUR YEARS AS AUTHORIZED UNDER SECTION 1011.71(9), FLORIDA STATUES (2015), AND THE SUBSTANCE OF THE MEASURE AND THE BALOT TITLE SHALL BE AS FOLLOWS:

BALLOT TITLE: APPROVAL OF THE CONTINUATION OF ONE-HALF MILL AD VALOREM TAX FOR SCHOOL DISTRICT OPERATING EXPENSES

BALLOT QUESTION: Shall the Pinellas County School District ad valorem millage of one-half mill per year be continued beginning July 1, 2017 and ending four fiscal years later on June 30, 2021, for necessary operating expenses including funds to recruit and retain teachers; preserve reading programs and music and art classes; and provide up-to-date textbooks and technology, with oversight of these expenditures by an independent citizens financial oversight committee?

XIII. New Business

A. Items Introduced by Superintendent

- Dr. Grego's report included the following:
- 1) He shared information about the Summer Reading Initiative, created to prevent summer learning loss. The goal is to put books into the hands of students, track their progress and provide incentives and increase school and community engagement in reading. A Fill the Bus drive kicks off April 25; there will be several drop-off locations. More details and opportunities to donate are listed on the district website at pcsb.org/summer reading.
- 2) He stated that on March 30 he joined Hillsborough County's Superintendent Jeff Eakins to host GradNation. More than 200 high school students from both counties came together to exchange ideas on how to increase the on-time high school graduation rate to 90 percent by the year 2020. Several GradNation summits were held across the county; the event we held was the only student-led summit in the nation.
- 3) He shared that Jaycelynn Dowdy, a fifth grade student at Curlew Creek Elementary was named the statewide winner of the 2015-16 Florida Missing Children's Day Essay Contest. This contest is open to all fifth graders in the state of Florida and focuses on what children can do to keep themselves safe from abduction while at home, school or away from their parents. On Monday, September 12, 2016, Jaycelynn will be honored at the State Capitol. She will read her essay to the audience. She won a prize package that includes a trophy, \$100 cash and a trip to Universal Studios.
- 4) He spoke about the recent Tarpon Springs pool groundbreaking ceremony. Due to the collaboration between Pinellas County Schools and the City of Tarpon Springs there will be a pool which can be used by students and residents. He thanked Mayor Archie, the Tarpon Springs' community and the School Board for partnering to provide this resource.
- 5) He congratulated the Tarpon Springs High School Color Guard for being named the Scholastic World Champions in Dayton, Ohio. They competed against guards from across the country and earned the top score by nearly three full points, which is a rare occurrence. They earned the top spot in 2014, also.
- 6) He said student teams from Dunedin Highland Middle School, Forest Lakes Elementary, Morgan Fitzgerald Middle School and Carwise Middle School competed in the state Odyssey of the Mind Competition held at the University of Central Florida. Dunedin Highland Middle School placed first in one category and second in another. Forest Lakes Elementary placed second in their division. These teams will be invited to the World Finals at lowa State University in May.
- 7) He spoke about the PRIDE awards; Program to Recognize Initiative and Distinction in Education. This award honors fifth grade students who excel in math, science, social studies, and writing and eighth grade students who excel in math, science, social studies, writing and world languages. The event was held at Ruth Eckerd Hall. He thanked the Pinellas Education Foundation for their support.
- 8) He said that tomorrow afternoon he will attend the Executive PASS program meeting at the Stavros Institute. Our PASS partnerships continue to grow. He said he is looking forward to hearing about the impact of this year's partnerships on schools in our district.
- 9) He said that on Thursday this week, he will be at the Tarpon Springs campus of St. Petersburg College to meet with their first cohort of students in the Elite Educator program. This program is possible through the district's partnership with St. Petersburg College. He thanked Dr. Law of SPC for his leadership.

Terry Krassner- She shared that she attended the Leadership U graduation ceremony. This program requires thirty-six hours of training; it builds relationships across the district; and encourages leadership in all staff.

She requested the Power Point presentations from this summit be shared with all board members. 2) She stated that two outstanding administrators are retiring. Ms. Linda Whitley, social studies supervisor, after 35 years and Ms. Pat Lusher, director, digital learning, after 39 years with the district. 3) She spoke about the district's program that allows students from economically disadvantaged families to take home laptops to aid their learning and the program we have with Bright House Networks to offer reduced rates to these families. She inquired about the possibility of WiFi hot spots since many families are unable to meet even the lower rate. 4) She asked if principals in the twelve Tumaround Schools will be given more autonomy over curriculum and the possibility of revisiting the idea of decentralized decision making. She asked that it be a workshop topic.

Rene Flowers- 1) She shared information about a community partnership event with USFSP and JDAI scheduled for Monday, April 18th from 9am-12noon at the Jackson Recreation Center, The Pursuit of Justice for Children and Youth and at the Johnson Library from 1-4 pm, An Introduction to Restorative & Trauma-Informed Practices. 2) She shared information about a community meeting being neld at PTC, St. Petersburg, 6-8:30 pm, on Tuesday, April 19th. The Enough is Enough; We Talk You Listen. Dr. Brimm is involved. 3) She spoke about Corey Thornton who led the FSA pep rally at Fairmount Park. She met him in the 1990's and commended him for his passion to share a positive message and for people to see beyond their present situation.
