As parents of one of the homeowners (Dr. Laura Muller), we know firsthand the intentions that the homeowners have to construct a handicapped accessible home on the property after the home is completed.

This is from two needs: Dr. Muller's sister, Stacy Martindale (our other daughter) suffers from the effects of a brain tumor diagnosed six years ago. She is able to walk only with assistance and would benefit greatly from a handicapped accessible home. Navigating the steps in the current home is difficult and dangerous. When we take Stacy to visit her sister in Palm Harbor, it is necessary for us to check into a hotel so that Stacy can use the elevator to her room and benefit from the bathroom facilities that are handicap accessible.

The second need is that all four of the parents of the homeowners are seventy years of age—or nearly so—and will in the future need access afforded by the proposed additions to the new home.

Closing the road would also benefit the tax based by the addition of the proposed home. Illinois Avenue is, according to our observations, lightly traveled and the neighbors would not be greatly inconvenienced by the closing.

To whom it may concern,

I am writing this letter to advocate for the vacating of the portion of 9th St between Ohio Ave and Illinois Ave in Palm Harbor Florida. After explanation and personal review of Drs. Chris and Laura Muller's plans for renewing and updating their property, I wholeheartedly believe the changes would be a benefit to the community.

As someone who frequently travels north/south through this neighborhood I don't believe these changes would interfere already existing traffic patterns. Ohio will now see less traffic being a dead-end and Illinois would not be any different than Ohio used to be. Traffic will only flow in one direction, around the corner like Ohio currently does. I don't see Ohio being a dead-end as a problem, with the knowledge that almost all the streets going east/west in the community are dead-ends already. These include: the other side of Ohio Ave, Illinois Ave, Natalie Ln, Wisconsin Ave, Claudia Ln, and Michigan Ave. Adding one more would not add any extra confusion as we, the community are not only aware of the proposed changes to come, but are supportive of it. The neighborhood seems like it's meant to be traveled through on 8th Street anyway, as it is the only north/south street with access from the north and the south, traveling on 9th street is only prudent if you live directly off the street.

The Muller's current property is a lush, tropical oasis that is an envy of many homeowners in the community. Expanding this, by replacing the empty lot and vacant duplex across the street from the Muller's current home with a continuous green paradise seems like it could only be a good thing. Many of the homes in the neighborhood are large homes with well-kept landscaping, many stories, and beautiful Floridian architecture; why prevent someone from elevating properties in the community to the already present standards. Making the community more aesthetically pleasing can only be a benefit. We, the community value these kinds of updates.

As someone with close ties to this specific community and wants the best for Palm Harbor and all it's neighborhoods, I have full faith that the vacating of the portion of 9th street should be allowed. Taking this first step to allowing The Muller's to help better the neighborhood should not be a problem for Pinellas Coun. I am excited to see how everything will turn out, but concerned for what the neighborhood would be like if no changes are allowed to be made.
