Message	I'm a banker by profession and deeply invested in the economic vitality of our county. I

also serve as Chair of the St. Petersburg Public Arts Commission, sit on the boards of Florida CraftArt and the St. Petersburg History Museum, and previously served on the SPAA board where I was an originating member and 10-year organizer of the SHINE Mural Festival. I share this because I've seen firsthand how Creative Pinellas drives both cultural credibility and economic growth—and why defunding it would be a serious setback for our community.

My hope is you will read my message with the urgency it needs.

1. Arts as a Core Economic Driver

Creative Pinellas is uniquely positioned to elevate St. Petersburg and Pinellas County as a true arts destination, not just a beach destination. While VSPC excels at promoting sand, sun, and hospitality, it does not carry the artistic credibility to speak to collectors, cultural tourists, and arts patrons.

- Arts tourism attracts higher-spending, longer-staying visitors than beach-only travelers.
- •Cities that have leaned into cultural identity—like Asheville, Austin, and Santa Fe—have proven that investing in the arts creates long-term, resilient tourism economies.

2. Authentic Community Roots

Creative Pinellas is deeply embedded in the local creative community: from public art initiatives, to artist residencies, to grants that nurture local talent.

- Visitors who travel for culture want an authentic experience, not a repackaged marketing campaign.
- •Creative Pinellas provides that authenticity, giving our local artists visibility and giving visitors a real sense of place.
- •By contrast, VSPC is a marketing agency, not a creator or cultivator of art. It doesn't commission, curate, or sustain creative work.

3. National & International Recognition

Creative Pinellas has built relationships with museums, galleries, and international arts organizations that give Pinellas County credibility on the global stage.

- •This type of arts diplomacy can't be outsourced to a tourism bureau.
- •It requires trust, curatorial expertise, and a proven track record—something VSPC does not have.

4. The Multiplier Effect

Funding for Creative Pinellas doesn't just support artists—it multiplies across the economy.

- •Local artists spend money locally, hire local assistants, rent local studios, and contribute to the fabric of neighborhoods.
- •Arts programs directly feed into hospitality, retail, and dining—creating a more holistic tourism experience.
- •Investment in the arts enhances quality of life, which in turn attracts businesses, relocations, and talent far beyond the arts sector.

5. Division of Strengths

This is not an "either/or"—it's about letting each organization play to its strengths.

- Visit St. Pete Clearwater is excellent at broad tourism marketing: beaches, resorts, family travel.
- •Creative Pinellas has the artistic pedigree, cultural networks, and credibility to make St. Pete/Pinellas a recognized arts hub.

Redirecting arts funding to VSPC dilutes impact, because it tries to make a marketing agency do something it is not designed or respected to do.

Closing Point

If we want St. Pete and Pinellas to compete with world-renowned arts destinations, we must fund the entity that actually produces, supports, and elevates the arts—Creative Pinellas. To shift that funding into a general tourism bureau would be a step backward, weakening our credibility in the arts world and undermining a proven driver of economic and cultural vitality.

I'm writing to express the profound and direct impact Creative Pinellas has had on my life and in the communities in which I have painted murals.

I'm a Florida native, and hold a BFA and an MFA in painting. I've spent my entire life creating and teaching my craft.

In 2023, I received a Public Arts Grant to work in collaboration with Florida Orange Groves Winery to create a mural on their building. The mural celebrated their history (a family owned business since the 1970s in South Pasadena) and welcomes the community and tourists who make their business a destination. Even several years later I am tagged by visitors in front of the mural. When I say NO ONE knows how to do public art like Creative Pinellas, I mean it. (I've worked with other CRAs and Cities in Florida so this comes from experience). I grew up in St. Petersburg. I spent all my school years in St. Pete and when I moved away for college, I decided that I wanted to work in the arts. I believe that this decision was in no small part because of Pinellas County's rich arts community and support for beautiful community pieces that celebrate EVERYONE in Pinellas. I know that Creative Pinellas plays a vital role in keeping the arts alive in my beloved hometown.

Creative Pinellas has always impressed me. With just 9 staff and a handful of supporting contractors, Creative Pinellas produces so much with so little. They are caretakers of one of the top reasons visitors come to the County: the Arts. They have managed the addition of over 50 public art projects in the County, helping beautification and safety efforts on places like the Pinellas Trail, South Pasadena, and Palm Harbor. They attract tourists with the projects Artists create with their support; they run a 10,000-square foot gallery at Pinewoods Cultural Park and the Sightline Gallery at PIE Airport; and they have a tourist-facing magazine to promote visitor spending. Creative Pinellas isn't a luxury — it's an engine for economic growth, tourism, education, and community wellbeing. Removing funding will cost the County much more in lost opportunity than it saves in the budget. Creative Pinellas turns public investment into high-impact programs that reach thousands of residents, students, and visitors — while leveraging

additional non-County funding.

When you think about the arts in the County, you might think about the new murals and signal box artworks that have beautified Lealman. Or you might think about the many murals you see when biking the Pinellas Trail. Or you might think about the Artists and Arts Nonprofits that received hurricane-relief funding last year. Or you might even think about the opposite – how blank and silent and uninspired our County would be without these things. Your continued funding of Creative Pinellas is what will help our County be a more vibrant place to visit and spend money – and not become empty. It's often so difficult to define the fabric that holds our communities together, so they are safe and attractive and vibrant for visitors. Creative Pinellas enhances that fabric every day, and we need not take it for granted as we consider the County budget.

My family's automotive dealerships have operated in Pinellas County for over 101 years and pay significant taxes each year. You can be assured that I understand and care deeply about how our tax dollars are used, about the bottom line and return on investment.

My background and education is in both Finance and Art Administration and I have spent 22+ years, 17 in NYC, working as a Cultural Strategist, helping global organizations and companies drive strategy by activating cultural strategies.

From my experience, as a cultural strategist and business leader and entrepreneur, I can tell you that defunding Creative Pinellas does not serve the best short or long term interest of residents and visitors to Pinellas County.

While it may seem an easy "budget cut" solution to those without an understanding of the full arts impacts, it actually risks eliminating earnings, profits and economic benefits in years to come.

As an arts professional, I am deeply troubled by the suggestion to defund Creative Pinellas, and I strongly urge you to continue supporting its funding.

In my travels to 26 countries—including several former Soviet nations—I've seen firsthand the lasting impact that sustained arts funding has on communities. The beauty of Italy and France, with their rich architecture, museums, and public art, stands in stark contrast to countries like Serbia or Bulgaria, where decades of neglect in arts funding or the promotion of artistic thought have left behind gray, uniform buildings with little vibrancy. It is a powerful reminder that the decision to cut arts funding can reshape a city, county, or country for generations, and not in a way that attracts people to live, work, or visit.

I understand that arts funding can sometimes feel like an easy target in today's political climate, but I ask that you carefully reconsider. These decisions affect more than budgets, they shape the cultural identity, livability, and tourism appeal of our community. People travel to Paris to see the Eiffel Tower and the Louvre, or to Italy to experience its artistic heritage; they rarely choose destinations where arts and culture have been diminished.

Creative Pinellas plays a vital role in sustaining our cultural ecosystem. With less than 1% of the county's tourism tax and only 0.004% of the overall Pinellas County budget, the organization delivers outsized impact through cultural tourism, grants, and arts advocacy. It also provides critical support to emerging artists, offering them opportunities to showcase their work publicly, and ensuring smaller cities within the county, which often lack dedicated arts professionals, still have access to artistic resources.

The grants Creative Pinellas provides not only nurture individual artists. but also reinvest directly back into the community. Removing this support risks silencing creative voices and diminishing the vibrancy that makes Pinellas County such a desirable place to live and visit.

I am writing to you in respect to the proposed defunding of Creative Pinellas. As the managing editor of Creative Pinellas' soon-to-launch online magazine, I urge you to continue funding Creative Pinellas rather than redirecting those dollars to Visit St. Pete- Clearwater.

While I only came on board back in May, as a longtime arts professional in Pinellas County and the former arts writer for the Tampa Bay Times, I have watched Creative Pinellas from its inception blossom into the organization it is today.

The impact of Creative Pinellas on the community includes, but is not limited to, the grants it provides to artists and arts organizations, although those are vital for building and maintaining the vibrant arts destination that is Pinellas County.

Creative Pinellas does so much for the arts in the community in myriad ways, including providing a place for artists to exhibit and sell work in the gallery, leading professional artist development workshops, placing artwork from Pinellas County artists at the St. Pete Clearwater International Airport, and on beautification projects throughout the county.

Because of the work Creative Pinellas does, Pinellas County youth get to experience participating in art, through exhibitions and art summer camps. This year, Creative Pinellas gave \$63,000 from the County General Fund directly to arts camps across Pinellas County—supporting program fees, need-based scholarships, and access for PCS students and families. Those kinds of experiences can be life-changing for kids.

Creative Pinellas is focused on being a driver of cultural tourism through two new initiatives, Making Waves, a new pilot program that connects the cultural community with the places people gather - Pinellas County's beautiful beaches, parks and outdoor spaces - to create a countywide exhibition with live performances and arts experiences.

CURRENT | CULTURE is our new online magazine geared toward attracting visitors to Pinellas County as a traveler's guide to local culture. It launches on Oct. 4. The magazine also pays local writers to contribute; another layer of the arts economy.

Please don't defund Creative Pinellas. It's a treasure and resource on which many Pinellas County residents rely.



My name is James Hartzell, resident for the past 10 years at 932 3rd St N in St Petersburg, FL. I am writing today about agenda item 25-1144A on tomorrow's meeting docket, September 4th 2025.

As I am unable to attend in person, the goal was to send in support via voicemail and email for Creative Pinellas. This vital arts organization must remain funded, to do otherwise would be a disservice to the community members your body represents.

Here are a few of the reasons why I feel so passionately about this issue.

Creative Pinellas has provided vital funding for artists across various mediums. St Petersburg's art scene was the top reason I moved here from Atlanta in 2015. Creative Pinellas has helped me discover, network with other fellow creatives and dream bigger on what goals can be achieved.

- CP programs & funded projects create a sense of community bringing people together, beautifying our urban environment and exhibiting unique visual storytelling that promotes insightful discussion. Diversity in representation from artists on display to subject matter, works of art that enrich our lives and can be a portal or mirror to illuminate important social issues.
- Personally assisted on a CP mural by Zulu Painter in Palm Harbor that transformed the wall at the intersection of Belcher and Alderman. Art in public spaces, from the Signal Box project to larger murals and installations are more than just decorative, they're powerful. Art in public spaces funded by CP uplift communities and can transform neighborhoods, along with how residents create a sense of pride, belonging and renewed interpretation of their environment.
- Also Creative Pinellas funds art projects that are economic drivers contributing directly to the economy by attracting visitors from within the county, across the state,

attracting tourists nationally and from around the world coming to our "Arts Coast" area to visit the outdoor galleries these murals create and support the businesses that surround them.

- Personally, I have been a recipient of the Creative Pinellas Impact Fund Grant within the last 9 months to paint a mural at the Rowdies stadium. Funds and technical support from CP were the biggest reason the mural happened after encountering various hurdles. The grant application process is competitive, they are not just handing out money. I've applied for seven years before earning a grant from CP.
- Impact to the next generation I've painted lettering murals on large shipping containers with a nonprofit organization Explore Spacecraft in 2023. These containers were outdoor classrooms that deployed to different communities over the years activating various types of learners through free programming. This was made possible by funds from Creative Pinellas to help pay instructors and other resources for the non-profit to serve the community directly in a setting that's more welcoming and than the structure of a school building. Learning with smaller class sizes and inspiring that vitally important next generation with programming built around the themes of Make, Play, Grow, Read.

In summary, defunding Creative Pinellas would be a terrible idea! This decision would not only create a vacuum in the arts community, but have a ripple effect beyond that.

It would negatively impact artists seeking help funding projects, hurt youth programming that inspire the next generation (think art summer camps), along with artists of various backgrounds and skill levels being denied the platform of exhibiting at Creative Pinellas' world class gallery space.

Think about the impact on neighborhoods losing out on a chance to create unique murals to liven up their community and all the businesses that have benefited from the tourism created by their proximity to arts projects funded by Creative Pinellas.

I urge you to reconsider plans to defund this immeasurably important arts organization. Creative Pinellas must remain as a pillar of the "Arts Coast" to help grow artists and the communities that benefit from the works they have created and hope to continue to bring forth into a world that needs art now more than ever.


