Description & Comments

(What is it, any issues found, is there a financial impact to current/next FY, does this contract vary from previous FY, etc.)

This item is a grant agreement between Florida Department of Environmental Protection (FDEP) and Pinellas County. It replaces grant agreement 18PI1, which was also a cost reimbursement-based grant for Coastal Management project 001515A - Treasure Island Nourishment 2018. 18PI1 expired before FDEP could provide task/deliverable approvals needed for reimbursement. Agreement 18PI2 will allow the County to seek reimbursement of 50% of non-federal project costs, up to \$2,540,000.00.

Treasure Island Nourishment is a completed project constructed by the United States Army Corps of Engineers. It was budgeted in the Capital Improvement Program from FY17 through FY22 and funded by Tourist Development Tax.

- Corrected figures within the Staff Report. They appear to be outdated. USACE provided a final balancing report in 2022. Revised figures are in line with USACE's reporting.
- The grant agreement provides reimbursement for up to \$2,540,000.00 of County expenses based on USACE's original total project estimate of \$12,000,000.00 plus monitoring. The final USACE Project cost was \$6,603,958.57. Therefore, the County will not need to request reimbursement for the full \$2,540,000.00 award.
 - Cost share Federal 58% and Nonfederal 48%. Nonfederal share is split between County and State at 50%.
- The County covered the full USACE project non-federal share of \$2,774,000.00. The anticipated reimbursement will reduce this cost 50%. Anticipated reimbursement \$1,407,000.00: \$1,387,000.00 for USACE Project and up to \$20,000.00 for monitoring.
