Chairman Justice read a proclamation recognizing June 19, 2022 as Juneteenth and discussed the significance of the holiday before inviting Ms. Campbell and her team to the podium; whereupon, Ms. Campbell made brief comments and thanked the Board for the recognition.

2. National Waste and Recycling Workers Week Proclamation:

Chairman Justice read a proclamation recognizing the week of June 17, 2022 as National Waste and Recycling Workers Week and acknowledged the importance of the work of waste and recycling collectors, material processors, and all others employed in the industry. Messrs. Sacco and Gloster and Ms. Meehan shared brief comments and expressed appreciation for the proclamation.

Chairman Justice invited Ms. Berman to the podium and read a proclamation recognizing June 2022 as Pride Month; whereupon, Ms. Berman thanked the Board for its support.

4. Partner Presentation:  
Hurricane Season Kickoff  
- Joe Borries, Operations Manager, Emergency Management

Referring to a PowerPoint presentation, Mr. Borries provided information regarding the Emergency Management Department's preparation for the upcoming hurricane season and discussed the preparedness messaging going out to the community, updates to the Ready Pinellas mobile application, efforts to improve upon and acquire additional shelter space, and various training exercises and workshops for community partners. He highlighted that the Department recently reviewed all hurricane evacuation zones in the County utilizing data from the National Hurricane Center; that evacuation levels for 47,000 parcels, equaling approximately 10% of all parcels, have been updated; and that affected residents received correspondence informing them of the changes.

Responding to queries by the members, Mr. Borries explained that shelters will adhere to 20 square feet per person in some cases, and 15 square feet per person in more crowded situations; that residents can navigate to the Emergency Management section of the Pinellas County website for a list of shelters, including those that are special needs and pet friendly; that per the aforementioned parcel update, risks associated with hurricanes increased for 6.6% of households and decreased for 2.6%; and that the County informs residents of their evacuation level in a variety of ways and invites citizens to visit [storm.pinellascounty.org](http://storm.pinellascounty.org) for more information.

**Deviating from the agenda, Chair Justice indicated that Item No. 20 will be heard at this time.**

## COUNTY ADMINISTRATOR DEPARTMENTS

### Safety and Emergency Services

20. Interlocal Agreement to create the Pinellas Regional Information Management Enterprise made up of the Cities of Clearwater, Largo, Pinellas Park, St. Petersburg, and Tarpon Springs as well as the Safety and Emergency Services Department and the Pinellas County Sheriff's Office.

Agreement approved. Pinellas County to pay a not-to-exceed amount of \$9,300,000.00, excluding pro rata costs, of the total \$15,000,000.00 amount for initial system costs; agreement term is five years, with automatic one-year renewals, not to exceed ten years.

City of Clearwater Chief of Police Dan Slaughter provided an overview of the agreement, indicating that following a review of the Parkland school shooting incident, it was realized that there is an efficiency to be gained by having all of the County's emergency services on a singular computer-aided dispatch platform; whereupon, he emphasized the importance of collaboration of the parties.

Responding to queries by the members, Chief Slaughter highlighted the following topics:

- Work process and public-facing component improvements
- Law enforcement agencies included on the platform
- Funding and cost to the County

**BOARD OF COUNTY COMMISSIONERS****8. Ordinance updates to Chapter 14 of the Pinellas County Code relating to animals specifically regarding the retail sale of dogs and cats in Pinellas County.**

Ordinance No. 22-20 adopted approving the updates to Chapter 14 of the Pinellas County Code relating to animals. Fifteen emails in support of the proposed ordinance, 80 emails supporting a full retail ban with no grandfathering of existing stores, and 4 emails opposing a retail ban on pet sales have been received.

Animal Services Director Doug Brightwell referred to a PowerPoint presentation and provided information regarding the Department's research of the pet breeding and retail sale industry and regulations pertaining to animal welfare, consumer protections, and actions by local jurisdictions on retail pet sales.

Mr. Brightwell noted that the research was conducted pursuant to the Board's request, following its adoption of a one-year moratorium on the expansion of commercial locations engaged in the retail sale of cats and dogs; that it supports findings by the United States Department of Agriculture's (USDA) Inspector General, highlighting that the USDA is not adequately regulating the dog breeding industry, nor is it effectively safeguarding the health and welfare of the dogs being produced by the industry; that Florida's Pet Lemon Law provides minimal protection for consumers; that there are 76 Florida jurisdictions, as well as 5 states, with full or partial bans on retail pet sales; and that the proposed ordinance would ban any new pet stores opening in the County and grandfather the existing stores with additional regulations, including not allowing expansion or relocation.

Chairman Justice indicated that the Board has the options of taking no action on retail pet sales, limiting any new development in conjunction with a grandfathering clause for existing stores, or a full retail ban; whereupon, in response to queries by the members, Mr. Brightwell noted that the proposed ordinance includes heightened regulations for the existing pet stores, including requiring the point of sale certificates and Official Certificate of Veterinary Inspection (OCVI) for each animal sold to be submitted to the Animal Services Department in a timely fashion, minimum cage requirements for dogs based on their size, and requiring information from the OCVI, along with other medical information, to be posted on the cages in the larger font.

Responding to queries by Commissioner Eggers, Mr. Brightwell explained that regulations regarding the isolation and treatment of sick animals in pet stores already exist; that Florida statutes provide for the reimbursement of certain veterinary bills accrued after the purchase of a pet at a retail store; however, the compensation cannot exceed the price that was paid for the pet; and that he will seek the County Attorney's advice regarding the possibility of increasing the compensation.

Upon call by the Chairman for public comment, the following individuals expressed their concerns, citing the inhumane treatment at puppy mills, health issues and living conditions of puppies purchased at pet stores, overcrowding at animal shelters and rescue groups, and other issues. During public comment, Chairman Justice, with input by Commissioner Flowers, noted that the proposed ordinance does not specifically address rabbits or puppy mills.

**Meeting Recessed: 12:15 P.M.**

**Meeting Reconvened: 12:50 P.M.**

Responding to queries by Commissioner Seel, Mr. Brightwell noted that pet retail stores are required to buy their animals from USDA licensed breeders; that hobby breeders are subject to minor regulations; and that the proposed ordinance does not apply to hobby breeders; whereupon, lengthy discussion ensued on the following and other topics, with input from Mr. Brightwell and Attorney White:

- Sourcing of the animals sold at pet retail stores
- Regulations of rescue organizations and the purchasing of animals online
- Animal populations at County shelters and Departmental resources for the owners struggling to care for their pet due to behavioral and/or financial issues
- Living conditions and health of animals at pet retail stores
- The number of animals annually sold at pet retail stores and what percentage of them stays in the County
- Information given to consumers when purchasing an animal at a pet retail store

During discussion and in response to queries by the members, Mr. Brightwell clarified that his Department receives 3 to 4 complaints about the pet retail stores each month; that the number of complaints is low compared to the number of sales; that it has been a couple of years since his Department has issued a violation to any of the stores; that Animal Services has the appropriate staffing to enforce the set of regulations in the proposed ordinance; and that the proposed ordinance allows for the suspension or revoking of a store's permit to sell pets pursuant to their failure to correct violations, depending on their severity.

Commissioner Peters related that some rescue organizations in the states where pet retail sales are banned are buying animals for sale and profit, and reiterated her interest in having staff look into whether that occurs locally; whereupon, she opined that a full pet retail ban would facilitate black market activity, void of any animal protection.

Thereupon, in regards to concerns by Commissioner Flowers addressing recent legislation on ordinances that negatively impact the revenue of business entities, Attorney White discussed possible ramifications and the effective date of the related Senate Bill 620, indicating that it has not yet been presented to the Governor to be signed; that other jurisdictions throughout Florida that have passed similar bans on pet retail stores have been exposed to lawsuits, which have largely been abandoned; and that if the Board adopts the ordinance, the County would likely be susceptible to business damage lawsuits.

Responding to queries by the members, Attorney White noted that the proposed ordinance provides for the right of the existing grandfathered stores to transfer, assign, or sell their business with the stipulation that the new ownership maintain compliance with the ordinance; and that the County could be more stringent than State statutes by requiring the stores to pay more than the price of an animal sold in potential veterinary bills incurred by the owner following the purchase.

Commissioner Long recommended that the proposed ordinance include language about a downsize option for the retail stores; whereupon, Commissioner Seel indicated that she was going to move that the proposed ordinance be approved as-is, but will accept a request by Commissioner Long as a friendly amendment. Commissioner Peters seconded the motion, and discussion continued.

Attorney White distributed a copy of the ordinance with the updated language, stating that per the Board's discussion at a recent work session, the update allows for a retail pet store to relocate as long as there is a net reduction in the pet sales aspect of the business; and that in response to comments received from a hobby breeder, the County Attorney's Office recommends adding a clause to exclude hobby breeders from the ordinance's definition of "commercial establishment" to clarify that the regulations set forth do not extend to them, noting that the clause is also included in the updated language; whereupon, Chief Assistant County Attorney Don Crowell provided an overview of the updated language to the ordinance.

Following discussion regarding the legality of including a ban on the retail sale of rabbits in the proposed ordinance in the context of Senate Bill 620, and the definition of a hobby breeder, Commissioners Seel and Peters confirmed that the updated language regarding relocation and hobby breeders are incorporated in the motion and second, and responding to query by Chair Justice, Commissioner Gerard indicated that she favors a complete ban of pet retail stores.



In response to queries by the members, Mr. Brightwell provided clarifying comments regarding the time frame for compensation of veterinary bills following the purchase of an animal at a retail pet store and noted that Animal Services does not have any oversight or authority over rescues that would allow for the regulation of the sourcing of the animals.

Responding to queries by Commissioner Seel, Attorney White related that notices to the public for ordinances include a provision that states that modifications may occur upon input received at the public hearing, however, it is not a guarantee that a modification would not be challenged. Mr. Brightwell noted that there are 12 to 14 stores selling pet rabbits in the County; that Animal Services has never regulated rabbits or had care, cage, food, or veterinary requirements for them; and that the Department would have to determine best practices, veterinary care requirements, and acquire other information if they were to regulate and inspect pet rabbits; whereupon, Attorney White remarked that the Board needs a basis upon which to move forward with a regulatory ordinance, as the action may otherwise appear arbitrary, capricious, and may not look grounded in well-founded research.

**A motion was made by Commissioner Seel, seconded by Commissioner Peters, that the proposed ordinance be approved as amended to specify that it does not apply to hobby breeders and to address relocation of pet stores. The motion carried by the following vote:**
