# ASBESTOS SAFETY SHEET

## IDENTIFICATION AND MITIGATION

**Asbestos is not allowed for disposal at C&D facilities like GET Clearwater. There are ways to identify the material prior to disposal in order to reject a load that contains asbestos. Best practices can also mitigate the dangers of asbestos in the event that some finds its way into the C&D waste stream.**

### **What is asbestos?**

Asbestos is a building material that was commonly used prior to 1980. Also known as “rock wool”, it was primarily used as an insulator and can be found in insulation, flooring, roofing, and textured coatings

### **How to identify asbestos:**

1. Age – ask the customer if they are aware of the age of the building/structure where the debris came from. Look for clues to the age of the debris like labels, style, or types of debris. Debris from a structure older than 1980 may contain asbestos
2. Texture – asbestos often appears as bundles of thin fibers. The most dangerous forms of asbestos are “friable” which means they can be easily broken into fibers, particles and dust by hand
3. Structure – asbestos containing materials, like pipe lagging, insulation, roofing and siding, may have a layered or wrapped appearance. The material may be fibrous, rough or have a dimpled surface
4. Color – asbestos typically has color ranging from white to brown to blue/gray
5. Associated debris – asbestos was used as a fire retardant, so associated debris may include furnaces, heat ducts, and fireplaces
6. Manufacturer labels – check to see if you can find a manufacturer label, as these might state whether the material contains asbestos

### **Mitigation of asbestos risk:**

1. Reject suspicious loads – if you are concerned that a load may contain asbestos based on the above criteria, reject the load.
2. Dust control – Asbestos fibers are most dangerous when airborne. Keeping the material wet will abate much of the risk associated with asbestos by keeping it from becoming airborne. Dust mitigation measures in place at our facility will mitigate the risk of asbestos exposure. Keep the sprinklers on and the materials wet and keep the floor/drive clean to prevent dust.

(15) Dust. The owner or operator of a solid waste management facility shall not allow the unconfined emissions of particulate matter in violation of paragraph 62-296.320(4)(c), F.A.C.

Fla. Admin. Code Ann. R. 62-296.320 - General Pollutant Emission Limiting Standards

(4) General Particulate Emission Limiting Standards. The following emission limiting standards shall apply to emissions units of particulate matter not subject to a particulate emission limit or opacity limit set forth in or established elsewhere in this chapter.

(c) Unconfined Emissions of Particulate Matter.

1. No person shall cause, let, permit, suffer or allow the emissions of unconfined particulate matter from any activity, including vehicular movement; transportation of materials; construction, alteration, demolition or wrecking; or industrially related activities such as loading, unloading, storing or handling; without taking reasonable precautions to prevent such emissions.

2. Any permit issued to a facility with emissions of unconfined particulate matter shall specify the reasonable precautions to be taken by that facility to control the emissions of unconfined particulate matter.


3. Reasonable precautions include the following:

a. Paving and maintenance of roads, parking areas and yards.


b. Application of water or chemicals to control emissions from such activities as demolition of buildings, grading roads, construction, and land clearing.






