OMB's has no objection to the department submitting a grant application to the US Department of Justice, Bureau of Justice Assistance (BJA) and the US Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA) to obtain funding on behalf of the Sixth Judicial Circuit to expand and enhance the capacity of its Adult Drug Court program.

- US Department of Justice, BJA, and US Department of Health and Human Services, SAMHSA, Joint Adult Drug Court Solicitation to Enhance Services, Coordination and Treatment for maximum of \$1,275,000 (\$300,000 from BJA and \$975,000 from SAMHSA). – A match is required for the BJA funding. The proposed match requirement is a minimum of \$100,000. It is proposed that the sources of the match are State of Florida, State Court System, \$91,125 in-kind; and WestCare Gulfcoast Florida, \$9,000, cash. The total grant request is \$1,375,125 over a 3 year period or \$450,375 per year.
